Presentation by Electric Utilities on the Effects of the New EPA Regulations

Bill Eastman, Director of Environmental Services, Westar, ([Attachment 1](#)), spoke to the committee on where Westar stands in relation to the new EPA regulations. He noted that the recent change in deadline for compliance was a huge relief for them.

Phil Wages, KEPCo, ([Attachment 2](#)), spoke briefly to the committee on the effects of the EPA regulations on their member companies.

Whitney Damron, Empire District Electric Company ([Attachment 3](#)), offered detailed information about the EPA regulations and how it is affecting their production of energy and compliance to the rules set forth. He also gave some estimated costs to the company of complying with these new regulations.

Kimberly Svaty, Kansas Power Pool, ([Attachment 4](#)), offered information to the committee about the effects of the EPA regulations on their production and costs. She noted there are 306 electric generation plants affected by the Reciprocating Internal Combustion Engine (RICE) rules. She spoke about some of their efforts in how they have been working to overturn the rules for municipal electric utilities by introduction of bills in the U.S. House and Senate.

Patrick Cassidy, Director of Environmental Services, Kansas City Board of Public Utilities, ([Attachment 5](#)), spoke about the specific costs to their company and customers of moving their energy generation facilities into compliance with the EPA rulings. He noted the time frame that was given them by the EPA was not even one budget cycle and basically made it virtually impossible to come into compliance within the time frame recommended.

Wayne Penrod, Sunflower Energy, ([Attachment 6](#)), spoke to the committee about the effects of the EPA rules on their operations. The rules affecting them are: Cross State Air Pollution Rule (CSAPR), Mercury and Air Toxic Standards (MATS) rule, Performance Standards for Greenhouse Gasses, and the Coal Combustion Residuals.

Paul Ling, KCPL, ([Attachment 7](#)) offered written testimony explaining the affects of the EPA rules on their company.

Earnie Lehman, Midwest Energy, ([Attachment 8](#)), presented a written explanation of the effects of the EPA rules on their company.

Questions were asked and comments made by Representatives: Joe Seiwert, Don Hineman, Phil Hermanson, Tom Sloan, Carl Holmes, Forrest Knox, and Vern Swanson.
