## SENATE BILL No. 288

AN ACT concerning drivers' licenses; authorizing certain individuals with
 revoked licenses to be eligible for restricted driving privileges;
 amending K.S.A. 8-2110 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

6 Section 1. K.S.A. 8-2110 is hereby amended to read as follows: 8-7 2110. (a) Failure to comply with a traffic citation means failure either to: 8 (1) Appear before any district or municipal court in response to a traffic 9 citation and pay in full any fine and court costs imposed; or (2) otherwise 10 comply with a traffic citation as provided in K.S.A. 8-2118, and 11 amendments thereto. Failure to comply with a traffic citation is a 12 misdemeanor, regardless of the disposition of the charge for which such 13 citation was originally issued.

14 (b) (1) In addition to penalties of law applicable under subsection (a), when a person fails to comply with a traffic citation, except for illegal 15 16 parking, standing or stopping, the district or municipal court in which the person should have complied with the citation shall mail notice to the 17 18 person that if the person does not appear in district or municipal court or 19 pay all fines, court costs and any penalties within 30 days from the date of 20 mailing notice, the division of vehicles will be notified to suspend the 21 person's driving privileges. The district or municipal court may charge an 22 additional fee of \$5 for mailing such notice. Upon the person's failure to 23 comply within such 30 days of mailing notice, the district or municipal 24 court shall electronically notify the division of vehicles. Upon receipt of a 25 report of a failure to comply with a traffic citation under this subsection, 26 pursuant to K.S.A. 8-255, and amendments thereto, the division of 27 vehicles shall notify the violator and suspend the license of the violator 28 until satisfactory evidence of compliance with the terms of the traffic 29 citation has been furnished to the informing court. When the court 30 determines the person has complied with the terms of the traffic citation, 31 the court shall immediately electronically notify the division of vehicles of 32 such compliance. Upon receipt of notification of such compliance from the 33 informing court, the division of vehicles shall terminate the suspension or 34 suspension action.

35 (2) (A) In lieu of suspension under paragraph (1), the driver may 36 submit to the division of vehicles a written request for restricted driving 1 privileges.

2 (B) (i) A person whose driving privileges have been revoked solely 3 for driving a motor vehicle on any highway as defined in K.S.A. 8-1424, 4 and amendments thereto, of this state at a time when such person's privilege to do so was canceled, suspended or revoked for failure to 5 6 comply with a traffic citation pursuant to this section may submit to the 7 division of vehicles a written request for restricted driving privileges. A 8 person shall not qualify for restricted driving privileges pursuant to this 9 section if such person has been convicted for driving with a canceled, 10 suspended or revoked license more than three times or if such person is suspended for reasons not included in this section at the time of 11 12 application. Restricted driving privileges approved pursuant to this subparagraph shall remain in effect unless otherwise rescinded for the 13 14 lesser of time of either:

15 *(a)* The remainder of the period of time that such person's driving 16 privileges are revoked; or

(b) three years from the date when the restricted driving privilegeswere approved.

(ii) The division shall rescind restricted driving privileges for any
person authorized pursuant to this subparagraph if the person is found
guilty of a violation resulting in a license suspension, revocation or
cancellation for reasons other than failure to comply with a traffic
citation.

(iii) A person operating a motor vehicle in violation of restrictions
provided in clause (i) shall be guilty of operating a vehicle in violation of
restrictions as provided in K.S.A. 8-291, and amendments thereto.

27 (C) A person whose driver's license has expired during the period 28 when such person's driver's license has been suspended for failure to pay 29 fines for traffic citations, the driver may submit to the division of vehicles 30 a written request for restricted driving privileges. An individual shall not 31 qualify for restricted driving privileges pursuant to this section unless the 32 following conditions are met: (i) The suspended license that expired was 33 issued by the division of vehicles; (ii) the suspended license resulted from 34 the individual's failure to comply with a traffic citation pursuant to 35 subsection (b)(1); and (iii) the traffic citation that resulted in the failure to 36 comply pursuant to subsection (b)(1) was issued in this state.

37  $(\bigcirc)(D)$  Upon review and approval of the driver's eligibility, the 38 driving privileges will be restricted by the division of vehicles for a period 39 up to one year *for restricted driving privileges issued pursuant to* 39 *subparagraph (A) or (C), for the period of time specified in subparagraph* 41 *(B)* or until the terms of the traffic citation have been complied with and 42 the court shall immediately electronically notify the division of vehicles of 43 such compliance. If the driver fails to comply with the traffic citation

within the one year restricted period, the driving privileges will be 1 2 suspended by the division of vehicles until the court determines the person 3 has complied with the terms of the traffic citation and the court shall 4 immediately electronically notify the division of vehicles of such 5 compliance. Upon receipt of notification of such compliance from the 6 informing court, the division of vehicles shall terminate the suspension 7 action. When restricted driving privileges are approved pursuant to this 8 section, the person's driving privileges shall be restricted to driving only 9 under the following circumstances: (i) In going to or returning from the 10 person's place of employment or schooling; (ii) in the course of the person's employment; (iii) in going to or returning from an appointment 11 12 with a health care provider or during a medical emergency; and (iv) in 13 going to and returning from probation or parole meetings, drug or alcohol 14 counseling or any place the person is required to go by a court.

15 (c) On and after July 1, 2018, except as provided in subsection (d), 16 when the district or municipal court notifies the division of vehicles of a 17 failure to comply with a traffic citation pursuant to subsection (b), the 18 court shall assess a reinstatement fee of \$100 for each charge on which the 19 person failed to make satisfaction regardless of the disposition of the 20 charge for which such citation was originally issued and regardless of any 21 application for restricted driving privileges. Such reinstatement fee shall 22 be in addition to any fine, restricted driving privilege application fee, 23 district or municipal court costs and other penalties. The court shall remit 24 all reinstatement fees to the state treasurer in accordance with the 25 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of 26 each such remittance, the state treasurer shall deposit the entire amount in 27 the state treasury and shall credit the first \$15 of such reinstatement fee to 28 the state general fund and of the remaining amount, 29.41% of such moneys to the division of vehicles operating fund, 22.06% to the 29 30 community alcoholism and intoxication programs fund created by K.S.A. 31 41-1126, and amendments thereto, 7.36% to the juvenile alternatives to 32 detention fund created by K.S.A. 79-4803, and amendments thereto, and 33 41.17% to the state general fund.

34 (d) The district court or municipal court shall waive the reinstatement 35 fee provided for in subsection (c), if the failure to comply with a traffic 36 citation was the result of such person enlisting in or being drafted into the 37 armed services of the United States, being called into service as a member 38 of a reserve component of the military service of the United States, or 39 volunteering for such active duty, or being called into service as a member 40 of the state of Kansas national guard, or volunteering for such active duty, 41 and being absent from Kansas because of such military service.

42 (e) (1) A person who is assessed a reinstatement fee pursuant to 43 subsection (c) may petition the court that assessed the fee at any time to 1 waive payment of the fee, any additional charge imposed pursuant to 2 subsection (f), or any portion thereof. If it appears to the satisfaction of the 3 court that payment of the amount due will impose manifest hardship on the 4 person or the person's immediate family, the court may waive payment of 5 all or part of the amount due or modify the method of payment.

6 (2) A person who is assessed a fine or court costs for a traffic citation 7 may petition the court that assessed the fine or costs at any time to waive 8 payment of the fine or costs, or any portion thereof. If it appears to the 9 satisfaction of the court that payment of the amount due will impose 10 manifest hardship on the person or the person's immediate family, the 11 court may waive payment of all or part of the amount due or modify the 12 method of payment.

(f) Except as provided further, the reinstatement fee established in this section shall be the only fee collected or moneys in the nature of a fee collected for such reinstatement. Such fee shall only be established by an act of the legislature and no other authority is established by law or otherwise to collect a fee. On and after July 1, 2019, through June 30, 2025, the supreme court may impose an additional charge, not to exceed \$22 per reinstatement fee, to fund the costs of non-judicial personnel.
