2021 Session Deadlines

The following dates are the deadlines for introduction and consideration of bills for the 2021 session. These deadlines were adopted as part of the Joint Rules of the Senate and House of Representatives for the 2021-2022 biennium.

Monday, February 1st

Last day for <u>member</u> or <u>members</u> to REQUEST bill drafts from Revisor's office.

Monday, February 8th

Last day for <u>non-exempt Committees</u> to REQUEST bill drafts from the Revisor's office.

Note: This is the last day requests for introduction can be on non-exempt committee agendas.

Wednesday, February 10th

Last day for <u>individuals</u> to INTRODUCE bills in originating chamber. Note: Bills must be submitted to chamber staff during daily session for Introduction.

Friday, February 12th

Last day for <u>non-exempt committees</u> to INTRODUCE bills in originating chamber. Note: Bills must be submitted to chamber staff during daily session for Introduction.

Friday, March 5th (Turnaround Day)

Last day to consider non-exempt bills in house of origin.

Friday, March 31st

Last day to consider non-exempt bills in either chamber.

Friday, April 9th (Drop Dead Day)

First adjournment.

Veto session is anticipated to begin on Monday, May 3rd.

Exempt committees: House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized.

Exempt bills are those sponsored by, referred to or acted upon by an exempt committee.
