Many changes are being looked at and they realize that this affects many people, not just deer hunters.

A final report from the Deer Task Force regarding the recommendations for changes in statutes will be presented to this Committee in January, 2007 with the hope of it remaining the same for at least a five year period.

There was a short discussion about chronic wasting disease on elk, deer, and moose which is different than mad cow disease.

Chairman Myers expressed appreciation to the Kansas Department of Wildlife and Parks for their work on this report.

Chairman Myers announced a hearing on <u>HB 2561</u> on February 6, no Committee meeting on February 8, and a hearing on <u>HCR 5034</u> on February 15.

Chairman Myers adjourned the meeting at 4:10.
