Bank commissioner; appointment of regional managers and 75-3135a. financial examiner administrators. (a) Subject to the provisions of appropriation acts, the bank commissioner may appoint a business manager, regional managers. and financial examiner administrators, case managers, and examiners within the office of the state bank commissioner as determined necessary by the bank commissioner to effectively carry out the mission of the office. The business manager, All regional managers, and financial examiner administrators, case managers, and examiners appointed after the effective date of this act April 30, 2012 shall be in the unclassified service under the Kansas civil service act, shall have special training and qualifications for such positions; and shall serve at the pleasure of the bank commissioner and shall receive compensation fixed by the bank commissioner and approved by the governor. The commissioner shall prepare and maintain an equitable salary schedule for such appointed positions, which allows for a comparison with similar positions with federal banking and consumer lending regulatory agencies. The commissioner's salary schedule shall not exceed ninety percent of the compensation provided for corresponding federal positions in similar The salary schedule shall be reported to the Kansas state geographic areas. banking board on an annual basis.

(b) Nothing in subsection (a) shall affect the classified status of any person employed in the office of the state bank commissioner on the day immediately preceding the effective date of this act. The provisions of this subsection shall not be construed to limit the powers of the bank commissioner pursuant to K.S.A. 75-2948 and amendments thereto.

75-2935b. Unclassified service; approval of compensation; exceptions. Salaries and other compensation of all persons who are within the unclassified service of the Kansas civil service act, and which salaries and other compensation are not fixed by statute, shall be subject to the approval of the governor and such salaries or other compensation shall not be paid until approved by the governor. The provisions of this section shall not apply to the salaries and other compensation of any officer or employee when such salary or other compensation is specifically prescribed by law, nor to officers and employees of elected state officials, officers and employees under the jurisdiction of the state board of regents, the executive secretary and other employees of the Kansas public employees retirement system that are in the unclassified service as specified under K.S.A. 74-4908 and amendments thereto, officers and employees of the Office of the State Bank Commissioner that are in the unclassified service as specified under K.S.A. 75-3135a, officers and employees of Kansas, Inc. and the Kansas technology enterprise corporation, officers and employees under the jurisdiction of the supreme court, legislative officers and employees or officers and employees of any agency performing functions and duties primarily for the legislative branch.
