8 *Be it enacted by the Legislature of the State of Kansas:*

9 Section 1. K.S.A. 2010 Supp. 8-1324 is hereby amended to read as
10 follows: 8-1324. (a) Any resident who does not hold a current valid Kansas
11 driver's license may make application to the division of vehicles and be
12 issued one identification card.

13 (b) For the purpose of obtaining an identification card, an applicant
14 shall submit, with the application, proof of age, proof of identity and proof
15 of lawful presence. An applicant shall submit with the application a photo
16 identity document, except that a non-photo identity document is acceptable
17 if it includes both the applicant's full legal name and date of birth, and
18 documentation showing the applicant's name, the applicant's address of
19 principal residence and the applicant's social security account number. The
20 applicant's social security number shall remain confidential and shall not
21 be disclosed, except as provided pursuant to K.S.A. 74-2012, and
22 amendments thereto. If the applicant does not have a social security
23 number, the applicant shall provide proof of lawful presence and Kansas
24 residency. The division shall assign a distinguishing number to the
25 identification card. Before issuing an identification card to a person, the
26 division shall make reasonable efforts to verify with the issuing agency the
27 issuance, validity and completeness of each document required to be
28 presented by the applicant to prove age, identity and lawful presence.

1 (c) The division shall not issue an identification card to any person
2 who fails to provide proof that the person is lawfully present in the United
3 States. If an applicant provides evidence of lawful presence as set out in
4 subsections (b)(2)(E) through (2)(I) of K.S.A. 8-240, and amendments
5 thereto, or is an alien lawfully admitted for temporary residence under
6 subsection (b)(2)(B) of K.S.A. 8-240, and amendments thereto, the
7 division may only issue a temporary identification card to the person under
8 the following conditions: (A) A temporary identification card issued
9 pursuant to this subparagraph shall be valid only during the period of time
10 of the applicant's authorized stay in the United States or, if there is no
11 definite end to the period of authorized stay, a period of one year; (B) a
12 temporary identification card issued pursuant to this subparagraph shall
13 clearly indicate that it is temporary and shall state the date upon which it
14 expires; (C) no temporary identification card issued pursuant to this
15 subparagraph shall be for a longer period of time than the time period
16 permitted by K.S.A. 8-1325, and amendments thereto; and (D) a
17 temporary identification card issued pursuant to this subparagraph may be
18 renewed, subject at the time of renewal, to the same requirements and
19 conditions set forth in this subsection (c) for the issuance of the original
20 temporary identification card.

21 (d) The division shall not issue an identification card to any person
22 who holds a current valid Kansas driver's license unless such driver's
23 license has been physically surrendered pursuant to the provisions of
24 subsection (e) of K.S.A. 8-1002, and amendments thereto.

25 (e) The division shall refuse to issue an identification card to a person
26 holding a driver's license or identification card issued by another state
27 without confirmation that the person is terminating or has terminated the
28 license or identification card.

29 (f) The parent or guardian of an applicant under 16 years of age shall
30 sign the application for an identification card submitted by such applicant.

31 (g) (1) The division shall require payment of a fee of \$14 at the
32 time application for an identification card is made, except that persons
33 who are 65 or more years of age or who are handicapped, as defined in
34 K.S.A. 8-1,124, and amendments thereto, shall be required to pay a fee of
35 only \$10. In addition to the fees prescribed by this subsection, the division
36 shall require payment of the photo fee established pursuant to K.S.A. 8-
37 243, and amendments thereto, for the cost of the photograph to be placed
38 on the identification card.

39 (2) *The division shall not require ~~or except~~ [accept] payment of*
40 *application or photo fees under this subsection for any person ~~18~~ [17]*
41 *years of age or older for purposes of meeting the voter ~~registration~~*
42 ***identification** requirements of K.S.A. ~~25-2309225-2908~~, and amendments*
43 *thereto. Such person shall ~~sign an affidavit to be submitted to the~~*

1 ~~secretary of revenue stating that such person plans to register to vote and~~
2 ~~that the person receives:~~

3 ~~(A) Food assistance, general assistance, supplemental security~~
4 ~~income (SSI), temporary assistance for families, medicaid assistance,~~
5 ~~united tribes food distribution program, bureau of Indian affairs general~~
6 ~~assistance, tribally administered temporary assistance for needy families,~~
7 ~~or meal assistance through the national school lunch program; or~~

8 ~~(B) resides in a household whose income is 150% or less of the~~

10 ~~(3) The secretary of revenue shall adopt rules and regulations in~~
11 ~~order to implement the provisions of paragraph (2).~~

12 ~~(4) Any person who signs an affidavit under paragraph (2) knowing~~
13 ~~the information is false shall be guilty of a class C misdemeanor. : (A)~~
14 ~~Swear under oath that such person desires an identification card in order to vote~~
15 ~~in an election in Kansas and that such person does not possess any of the forms~~
16 ~~of identification acceptable under K.S.A. 25-2908, and amendments thereto. The~~
17 ~~affidavit shall specifically list the acceptable forms of identification under K.S.A.~~
18 ~~25-2908, and amendments thereto.~~

19 ~~(B) Such person shall also produce evidence that such person is registered to~~
20 ~~vote in Kansas.~~

21 (h) All Kansas identification cards shall have physical security
22 features designed to prevent tampering, counterfeiting or duplication for
23 fraudulent purposes.

24 (i) For the purposes of K.S.A. 8-1324 through 8-1328, and
25 amendments thereto, a person shall be deemed to be a resident of the state
26 if:

27 (1) The person owns, leases or rents a place of domicile in this state;

28 (2) the person engages in a trade, business or profession in this state;

29 (3) the person is registered to vote in this state;

30 (4) the person enrolls the person's child in a school in this state; or

31 (5) the person registers the person's motor vehicle in this state.

32 (j) The division shall require that any person applying for an
33 identification card submit to a mandatory facial image capture.

34 (k) The director of vehicles may issue a temporary identification card
35 to an applicant who cannot provide valid documentary evidence as defined
36 by subsection (c), if the applicant provides compelling evidence proving
37 current lawful presence. Any temporary identification card issued pursuant
38 to this subparagraph shall be valid for one year.

39 (l) Upon payment of the required fee, the division shall issue to every
40 applicant qualifying under the provisions of this act an identification card.
41 Such identification card shall bear a distinguishing number assigned to the
42 cardholder, the full legal name, date of birth, address of principal
43 residence, a brief description of the cardholder, a colored digital

1 photograph of the cardholder, and a facsimile of the signature of the
 2 cardholder. An identification card which does not contain the address of
 3 principal residence of the cardholder as required may be issued to persons
 4 who are program participants pursuant to K.S.A. 2010 Supp. 75-455, and
 5 amendments thereto.

6 Sec. 2. K.S.A. 2010 Supp. 25-1122 is hereby amended to read as
 7 follows: 25-1122. (a) Any registered voter may file with the county
 8 election officer where such person is a resident, or where such person is
 9 authorized by law to vote as a former precinct resident, an application for
 10 an advance voting ballot. The signed application shall be transmitted only
 11 to the county election officer by personal delivery, mail, facsimile or as
 12 otherwise provided by law.

13 (b) If the registered voter is applying for an advance voting ballot to
 14 be transmitted in person, ~~and such voter is a first-time voter,~~ such voter
 15 shall provide *identification pursuant to K.S.A. 25-2908, and amendments*
 16 *thereto.* ~~a form of valid identification such as a current and valid Kansas~~
 17 ~~driver's license, nondriver's identification card, utility bill, bank statement,~~

 19 ~~the voter's current name and address as indicated on the registration book.~~

23 (c) If the registered voter is applying for an advance voting ballot to
 24 be transmitted by mail, ~~and such voter is a first-time voter,~~ such voter shall

 27 card number or *a photocopy of any other identification provided by K.S.A.*

 29 ~~security number, or shall provide with the application a copy of the voter's~~
 30 ~~current and valid Kansas driver's license, nondriver's identification card,~~

 37 ~~valid identification, or if the name and address do not match the voter's~~

 39 ~~provisional ballot according to K.S.A. 25-409, and amendments thereto, if:~~

40 **(1) The voter is unable or refuses to provide current and valid**
 41 **identification; or**

42 **(2) the name and address of the voter provided on the application**
 43 **for an advance voting ballot do not match the voter's name and**

1 **address on the registration book.** The voter shall provide a valid form of
2 identification as defined in ~~subsection (e) of K.S.A. 25-2908, and~~
3 ~~amendments thereto, this section~~ to the county election officer in person or
4 provide a copy by mail or electronic means before the meeting of the
5 county board of canvassers. At the meeting of the county board of
6 canvassers the county election officer shall present copies of identification
7 received from provisional voters and the corresponding provisional ballots.
8 If the county board of canvassers determines that a voter's identification is
9 valid and the provisional ballot was properly cast, the ballot shall be
10 counted.

11 *(e) No county election officer shall provide an advance voting ballot*
12 *to a person who is requesting an advance voting ballot to be transmitted*
13 *by mail unless:*

14 *(1) The county election official verifies that the signature of the*
15 *person matches that on file in the county voter registration records.*
16 *Signature verification may occur by electronic device or by human*
17 *inspection. In the event that the signature of a person who is requesting*
18 *an advance voting ballot does not match that on file, the county election*
19 *officer shall attempt to contact the person and shall offer the person*
20 *another opportunity to ~~mail in~~ provide such person's signature for the*
21 *purposes of verifying the person's identity. If the county election officer is*
22 *unable to reach the person, the county election officer may transmit a*
23 *provisional ballot, however, such provisional ballot may not be counted*
24 *unless a signature is included therewith that can be verified; and*

25 *(2) the person provides such person's full Kansas driver's license*
26 *number, Kansas nondriver's identification card number issued by the*
27 *division of vehicles, or submits such person's application for an advance*
28 *voting ballot and a copy of identification provided by K.S.A. 25-2908, and*
29 *amendments thereto, to the county election officer for verification. If a*
30 *person applies for an advance voting ballot to be transmitted by mail but*
31 *fails to provide identification pursuant to this subsection or the*
32 *identification of such person cannot be verified by the county election*
33 *officer, the county election officer shall provide information to such person*
34 *regarding the voter rights provisions of subsection (d) and shall provide*
35 *such person an opportunity to provide identification pursuant to this*
36 *subsection. For the purposes of this act, Kansas state offices and offices*
37 *of any subdivision of the state will allow any person seeking to vote by an*
38 *advance voting ballot the use a photocopying device to make one*
39 *photocopy of an identification document at no cost.*

40 ~~(e)~~(f) Applications for advance voting ballots to be transmitted to the
41 voter by mail shall be filed only at the following times:

42 (1) For the primary election occurring on the first Tuesday in August
43 in even-numbered years, between April 1 of such year and the last business

1 day of the week preceding such primary election.

2 (2) For the general election occurring on the Tuesday succeeding the
3 first Monday in November in even-numbered years, between 90 days prior
4 to such election and the last business day of the week preceding such
5 general election.

6 (3) For the primary election held five weeks preceding the first
7 Tuesday in April, between January 1 of the year of such election and the
8 last business day of the week preceding such primary election.

9 (4) For the general election occurring on the first Tuesday in April,
10 between January 1 of the year of such election and the last business day of
11 the week preceding such general election.

12 (5) For question submitted elections occurring on the date of a
13 primary or general election, the same as is provided for ballots for election
14 of officers at such election.

15 (6) For question submitted elections not occurring on the date of a
16 primary or general election, between the time of the first published notice
17 thereof and the last business day of the week preceding such question
18 submitted election, except that if the question submitted election is held on
19 a day other than a Tuesday, the county election officer shall determine the
20 final date for mailing of advance voting ballots, but such date shall not be
21 more than three business days before such election.

22 (7) For any special election of officers, at such time as is specified by
23 the secretary of state.

24 (8) For the presidential preference primary, between January 1 of the
25 year in which such primary is held and the last business day of the week
26 preceding such primary election.

27 The county election officer of any county may receive applications
28 prior to the time specified in this subsection (~~e~~) and hold such applications
29 until the beginning of the prescribed application period. Such applications
30 shall be treated as filed on that date.

31 (~~f~~)(g) Unless an earlier date is designated by the county election
32 office, applications for advance voting ballots transmitted to the voter in
33 person in the office of the county election officer shall be filed on the
34 Tuesday next preceding the election and on each subsequent business day
35 until no later than 12:00 noon on the day preceding such election. If the
36 county election officer so provides, applications for advance voting ballots
37 transmitted to the voter in person in the office of the county election
38 officer also may be filed on the Saturday preceding the election. Upon
39 receipt of any such properly executed application, the county election
40 officer shall deliver to the voter such ballots and instructions as are
41 provided for in this act.

42 An application for an advance voting ballot filed by a voter who has a
43 temporary illness or disability or who is not proficient in reading the

1 English language or by a person rendering assistance to such voter may be
 2 filed during the regular advance ballot application periods until the close
 3 of the polls on election day.

4 The county election officer may designate places other than the central
 5 county election office as satellite advance voting sites. At any satellite
 6 advance voting site, a registered voter may obtain an application for
 7 advance voting ballots. Such ballots and instructions shall be delivered to
 8 the voter in the same manner and subject to the same limitations as
 9 otherwise provided by this subsection.

10 ~~(g)~~(h) Any person having a permanent disability or an illness which
 11 has been diagnosed as a permanent illness is hereby authorized to make an
 12 application for permanent advance voting status. Applications for
 13 permanent advance voting status shall be in the form and contain such
 14 information as is required for application for advance voting ballots and
 15 also shall contain information which establishes the voter's right to
 16 permanent advance voting status.

17 ~~(h)~~(i) On receipt of any application filed under the provisions of this
 18 section, the county election officer shall prepare and maintain in such
 19 officer's office a list of the names of all persons who have filed such
 20 applications, together with their correct post office address and the
 21 precinct, ward, township or voting area in which such persons claim to be
 22 registered voters or to be authorized by law to vote as former precinct
 23 residents and the present resident address of each applicant. Such names
 24 and addresses shall remain so listed until the day of such election. The
 25 county election officer shall maintain a separate listing of the names and
 26 addresses of persons qualifying for permanent advance voting status. All
 27 such lists shall be available for inspection upon request in compliance with
 28 this subsection by any registered voter during regular business hours. The
 29 county election officer upon receipt of such applications shall enter upon a
 30 record kept by such officer the name and address of each applicant, which
 31 record shall conform to the list above required. Before inspection of any
 32 advance voting ballot application list, the person desiring to make such
 33 inspection shall provide to the county election officer identification in the
 34 form of driver's license or other reliable identification and shall sign a log
 35 book or application form maintained by such officer stating such person's
 36 name and address and showing the date and time of inspection. All records
 37 made by the county election officer shall be subject to public inspection,
 38 except that the voter identification information required by subsections (b)
 39 and (c) and the identifying number on ballots and ballot envelopes and
 40 records of such numbers shall not be made public.

41 ~~(i)~~(j) If a person on the permanent advance voting list fails to vote in
 42 two consecutive general elections held on the Tuesday succeeding the first
 43 Monday in November of each even-numbered year, the county election

1 officer may mail a notice to such voter. Such notice shall inform the voter
2 that the voter's name will be removed from the permanent advance voting
3 list unless the voter renews the application for permanent advance voting
4 status within 30 days after the notice is mailed. If the voter fails to renew
5 such application, the county election officer shall remove the voter's name
6 from the permanent advance voting list. Failure to renew the application
7 for permanent advance voting status shall not result in removal of the
8 voter's name from the voter registration list.
