1 AN ACT concerning ~~motor vehicles; relating to~~ distinctive license plates;
2 ~~providing for the ducks unlimited license plate amending K.S.A. 8-~~

7 *Be it enacted by the Legislature of the State of Kansas:*

8 *New Section 1.* (a) On and after January 1, 2013, any owner or lessee
9 of one or more passenger vehicles or trucks registered for a gross weight
10 of 20,000 pounds or less, who is a resident of Kansas, upon compliance
11 with the provisions of this section, may be issued one ducks unlimited
12 license plate for each such passenger vehicle or truck. Such license plates
13 shall be issued for the same time as other license plates upon proper
14 registration and payment of the regular license fee as provided in K.S.A. 8-
15 143, and amendments thereto, and the presentation of the annual logo use
16 authorization statement provided for in subsection (b). ***Presentation of the***
17 ***annual logo use authorization statement shall not be required by the***
18 ***county treasurer if the annual logo use royalty payment is paid to the***
19 ***county treasurer.***

20 (b) The board of directors of ducks unlimited may authorize the use
21 of their logo to be affixed on license plates as provided by this section.
22 Any royalty payment received pursuant to this section shall be paid to
23 ducks unlimited ***or a county treasurer*** and shall be used to support ducks
24 unlimited. Any motor vehicle owner or lessee annually may apply to
25 ducks unlimited ***or a county treasurer*** for the use of such logo. Upon
26 annual application and payment to ducks unlimited in an amount of not
27 less than \$25 nor more than \$100 as a logo use royalty payment for each
28 license plate to be issued, ducks unlimited ***or a county treasurer*** shall
29 issue to the motor vehicle owner or lessee, without further charge, a logo
30 use authorization statement, which shall be presented by the motor vehicle
31 owner or lessee at the time of registration. ***Presentation of the annual***
32 ***logo use authorization statement shall not be required by the county***
33 ***treasurer if the annual logo use royalty payment is paid to the county***
34 ***treasurer.***

35 (c) Any applicant for a license plate authorized by this section may
36 make application for such plates not less than 60 days prior to such

1 person's renewal of registration date, on a form prescribed and furnished
2 by the director of vehicles, and any applicant for such license plate shall
3 provide the annual logo use authorization statement provided for in
4 subsection (b). Application for registration of a passenger vehicle or truck
5 and issuance of the license plate under this section shall be made by the
6 owner or lessee in a manner prescribed by the director of vehicles upon
7 forms furnished by the director.

8 (d) No registration or license plate issued under this section shall be
9 transferable to any other person.

10 ***(e) The director of vehicles may transfer ducks unlimited license***
11 ***plates from a leased vehicle to a purchased vehicle.***

12 ~~(f)~~ ***(f)*** Renewals of registration under this section shall be made
13 annually, upon payment of the fee prescribed in subsection (a), in the
14 manner prescribed in subsection (b) of K.S.A. 8-132, and amendments
15 thereto. No renewal of registration shall be made to any applicant until
16 such applicant ***either*** provides the annual logo use authorization statement
17 provided for in subsection (b) ***or makes the annual logo use royalty***
18 ***payment to the county treasurer.*** If such logo use authorization statement
19 is not presented at the time of registration ***or faxed by duck unlimited, or***
20 ***the annual logo use royalty payment is not made to the county treasurer,***
21 the applicant shall be required to comply with K.S.A. 8-143, and
22 amendments thereto, and return the license plate to the county treasurer of
23 such person's residence.

24 ~~(g)~~ ***(g)*** Ducks unlimited shall:

25 (1) Pay the initial cost of silk-screening for license plates authorized
26 by this section; and

27 (2) provide to all county treasurers a toll-free telephone number
28 where applicants can call ducks unlimited for information concerning the
29 application process or the status of their license plate application.

30 ~~(h)~~ ***(h)*** Ducks unlimited, with the approval of the director of vehicles
31 and subject to the availability of materials and equipment, shall design a
32 plate to be issued under the provisions of this section.

33 ***(i) As a condition of receiving the ducks unlimited license plate and***
34 ***any subsequent registration renewal of such plate, the applicant must***
35 ***provide consent to the division authorizing the division's release of***
36 ***motor vehicle record information, including the applicant's name,***
37 ***address, logo use royalty payment amount, plate number and vehicle***
38 ***type to ducks unlimited and the county treasurer.***

39 ***(j) Annual royalty payments collected by county treasurers under this***
40 ***section shall be remitted to the state treasurer in accordance with the***
41 ***provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of***
42 ***each such remittance the state treasurer shall deposit the entire amount***
43 ***in the state treasury to the credit of the ducks unlimited royalty fund,***

1 *which is hereby created in the state treasury and shall be administered*
2 *by the state treasurer. All expenditures from the ducks unlimited royalty*
3 *fund shall be made in accordance with appropriations acts upon*
4 *warrants approved by the director of accounts and reports issued*
5 *pursuant to vouchers approved by the state treasurer or the state*
6 *treasurer's designee. Payments from the ducks unlimited royalty fund to*
7 *the appropriate designee of duck unlimited of Kansas shall be made on a*
8 *monthly basis.*

9 *New Sec. 2. On and after January 1, 2013, any owner or lessee of*
10 *one or more passenger vehicles or trucks registered for a gross weight of*
11 *20,000 pounds or less, who is a resident of Kansas, upon compliance*
12 *with the provisions of this section, may be issued one masonic lodge*
13 *license plate for each such passenger vehicle or truck. In addition to the*
14 *license plate, a person issued such license plate may request a decal of*
15 *various masonic designations, such as previous offices held in the*
16 *organization and organizational affiliations, as determined by the grand*
17 *lodge of Kansas. Such license plates shall be issued for the same time as*
18 *other license plates upon proper registration and payment of the regular*
19 *license fee as provided in K.S.A. 8-143, and amendments thereto, and*
20 *the presentation of the annual logo use authorization statement provided*
21 *for in subsection (b). Presentation of the annual logo use authorization*
22 *statement shall not be required by the county treasurer if the annual*
23 *logo use royalty payment is paid to the county treasurer. Presentation of*
24 *the annual logo use authorization statement shall not be required by the*
25 *county treasurer if the annual logo use royalty payment is paid to the*
26 *county treasurer.*

27 *(b) The grand lodge of ancient free and accepted masons of Kansas*
28 *may authorize the use of their logo to be affixed on license plates as*
29 *provided by this section. Any royalty payment received pursuant to this*
30 *section shall be paid to the grand lodge of ancient free and accepted*
31 *masons or a county treasurer and shall be divided to support the Kansas*
32 *masonic library and museum and other charities through Kansas*
33 *freemasons charities, inc. Any motor vehicle owner or lessee annually*
34 *may apply to the grand lodge of ancient free and accepted masons of*
35 *Kansas or a county treasurer for use of such logo. Upon annual*
36 *application and payment to the grand lodge of ancient free and accepted*
37 *masons of Kansas or a county treasurer in an amount of not less than*
38 *\$25 or more than \$100 as a logo use royalty payment for each license*
39 *plate to be issued, the grand lodge of ancient free and accepted masons*
40 *of Kansas or a county treasurer shall issue to the motor vehicle owner or*
41 *lessee, without further charge, a logo use authorization statement, which*
42 *shall be presented by the motor vehicle owner or lessee at the time of the*
43 *registration. Presentation of the annual logo use authorization statement*

1 *shall not be required by the county treasurer if the annual logo use*
2 *royalty payment is paid to the county treasurer. Presentation of the*
3 *annual logo use authorization statement shall not be required by the*
4 *county treasurer if the annual logo use royalty payment is paid to the*
5 *county treasurer.*

6 *(c) Any applicant for a license plate authorized by this section may*
7 *make application for such plates not less than 60 days prior to such*
8 *person's renewal of registration date, on a form prescribed and*
9 *furnished by the director of vehicles, and any applicant for such license*
10 *plates shall provide the annual logo use authorization statement*
11 *provided for in subsection (b). Application for registration of a*
12 *passenger vehicle or truck and issuance of the license plate under this*
13 *section shall be made by the owner or lessee in a manner prescribed by*
14 *the director of vehicles upon forms furnished by the director.*

15 *(d) No registration or license plate issued under this section shall*
16 *be transferable to any other person.*

17 *(e) The director of vehicles may transfer Masonic lodge license*
18 *plates from a leased vehicle to a purchased vehicle.*

19 *(f) Renewals of registration under this section shall be annually,*
20 *upon payment of the fee prescribed in subsection (b) of K.S.A. 8-132,*
21 *and amendments thereto. No renewal of registration shall be made to*
22 *any applicant until such applicant either provides the annual logo use*
23 *authorization statement provided for in subsection (b) or makes annual*
24 *logo use royalty payment to the county treasurer. If such logo use*
25 *authorization statement is not presented at the time of registration or*
26 *faxed by the masonic lodge, or the annual logo use royalty payment is*
27 *not made to a county treasurer, the applicant shall be required to comply*
28 *with K.S.A. 8-143, and amendments thereto, and return the license plate*
29 *to the county treasurer of such person's residence.*

30 *(g) The grand lodge of ancient free and accepted masons of Kansas*
31 *shall:*

32 *(1) Pay the initial cost of silk-screening plates authorized by this*
33 *section; and*

34 *(2) provide to all county treasurers a toll-free telephone number*
35 *where applicants can call the grand lodge of Kansas for information*
36 *concerning the application process or the status of their license plate*
37 *application.*

38 *(h) The grand lodge of ancient free and accepted masons of*
39 *Kansas, with the approval of the director of vehicles and subject to*
40 *availability of materials and equipment, shall design a plate to be issued*
41 *under the provisions of this section.*

42 *(i) A fee, as determined by the grand lodge of Kansas, may be*
43 *assessed for each decal issued under this section. Such decals shall be*

1 *affixed to the license plate in the location required by the director of*
2 *vehicles.*

3 *(j) As a condition of receiving the Masonic lodge license plate and*
4 *any subsequent registration renewal of such plate, the applicant must*
5 *provide consent to the division authorizing the division's release of*
6 *motor vehicle record information, including the applicant's name,*
7 *address, logo use royalty payment amount, plate number and vehicle*
8 *type to the masonic lodge and the county treasurer.*

9 *(k) Annual royalty payments collected by county treasurers under*
10 *this section shall be remitted to the state treasurer in accordance with*
11 *the provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt*
12 *of each such remittance the state treasurer shall deposit the entire*
13 *amount in the state treasury to the credit of the Masonic lodge royalty*
14 *fund, which is hereby created in the state treasury and shall be*
15 *administered by the state treasurer. All expenditures from the Masonic*
16 *lodge royalty fund shall be made in accordance with appropriations acts*
17 *upon warrants approved by the director of accounts and reports issued*
18 *pursuant to vouchers approved by the state treasurer or the state*
19 *treasurer's designee. Payments from the Masonic lodge royalty fund to*
20 *the appropriate designee of grand lodge of ancient and free accepted*
21 *masons of Kansas shall be made on a monthly basis.*

22 *Sec. 3. K.S.A. 2011 Supp. 8-1,141 is hereby amended to read as*
23 *follows: 8-1,141. (a) Any new distinctive license plate authorized for*
24 *issuance on and after July 1, 1994, shall be subject to the personalized*
25 *license plate fee prescribed by subsection (c) of K.S.A. 8-132, and*
26 *amendments thereto. This section shall not apply to any distinctive*
27 *license plate authorized prior to July 1, 1994.*

28 *(b) The director of vehicles shall not issue any new distinctive*
29 *license plate authorized for issuance on and after July 1, 1995, unless*
30 *there is a guarantee of an initial issuance of at least 500 license plates.*

31 *(c) The provisions of this section shall not apply to distinctive*
32 *license plates issued under the provisions of K.S.A. 8-1,145, or K.S.A.*
33 *2011 Supp. 8-177d, 8-1,163 or 8-1,166, and amendments thereto.*

34 *(d) The provisions of subsection (a), shall not apply to distinctive*
35 *license plates issued under the provisions of K.S.A. 8-1,146 or 8-1,148,*
36 *and amendments thereto, or K.S.A. 2011 Supp. 8-1,153, 8-1,158 or 8-*
37 *1,161, and amendments thereto.*

38 *(e) The provisions of subsection (f) shall not apply to distinctive*
39 *license plates issued under the provisions of K.S.A. 2011 Supp. 8-1,160,*
40 *and amendments thereto, except that the division shall delay the*
41 *manufacturing and issuance of such distinctive license plate until the*
42 *division has received not less than 1,000 orders for such plate, including*
43 *payment of the personalized license plate fee required under subsection*

1 *(a). Upon certification by the director of vehicles to the director of*
2 *accounts and reports that not less than 1,000 paid orders for such plate*
3 *have been received, the director of accounts and reports shall transfer*
4 *\$40,000 from the state highway fund to the distinctive license plate fund.*

5 *(f) (1) Any person or organization sponsoring any distinctive*
6 *license plate authorized by the legislature on and after July 1, 2004,*
7 *shall submit to the division of vehicles a nonrefundable amount not to*
8 *exceed \$20,000, to defray the division's cost for developing such*
9 *distinctive license plate.*

10 *(2) All moneys received under this subsection shall be remitted by*
11 *the secretary of revenue to the state treasurer in accordance with the*
12 *provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of*
13 *each such remittance, the state treasurer shall deposit the entire amount*
14 *in the state treasury to the credit of the distinctive license plate fund*
15 *which is hereby created in the state treasury. All moneys credited to the*
16 *distinctive license plate fund shall be used by the department of revenue*
17 *only for the purpose associated with the development of distinctive*
18 *license plates. All expenditures from the distinctive license plate*
19 *application fee fund shall be made in accordance with appropriation*
20 *acts, upon warrants of the director of accounts and reports issued*
21 *pursuant to vouchers approved by the secretary of the department of*
22 *revenue.*

23 *(g) (1) Except for educational institution license plates issued under*
24 *K.S.A. 8-1,142, and amendments thereto, the director of vehicles shall*
25 *discontinue the issuance of any distinctive license plate authorized prior*
26 *to July 1, 2004, and which is subject to the provisions of subsection (b)*
27 *if:*

28 *(A) Less than 500 license plates, including annual renewals, are*
29 *issued for that distinctive license plate by July 1, 2006; and*

30 *(B) less than 250 license plates, including annual renewals, are*
31 *issued for that distinctive license plate during any subsequent two-year*
32 *period after July 1, 2006.*

33 *(2) The director of vehicles shall discontinue the issuance of any*
34 *distinctive license plate authorized on and after July 1, 2004, if:*

35 *(A) Less than 500 plates, including annual renewals, are issued for*
36 *that distinctive license plate by the end of the second year of sales; and*

37 *(B) less than 250 license plates, including annual renewals, are*
38 *issued for that distinctive license plate during any subsequent two-year*
39 *period.*

40 *(h) An application for any distinctive license plate issued after*
41 *December 31, 2012, and the corresponding royalty fee may be collected*
42 *either by the county treasurer or the entity benefiting from the issuance of*
43 *the distinctive license plate. Annual royalty payments collected by the*

1 county treasurers shall be remitted to the state treasurer in accordance
2 with the provisions of K.S.A. 75-4215, and amendments thereto. Upon
3 receipt of each such remittance the state treasurer shall deposit the entire
4 amount in the state treasury to the credit of a segregated royalty fund
5 which shall be administered by the state treasurer. All expenditures from
6 the royalty fund shall be made in accordance with appropriation acts upon
7 warrants of the director of accounts and reports issued pursuant to
8 vouchers approved by the state treasurer or the state treasurer's designee.
9 Payments from the royalty fund shall be made to the entity benefiting from
10 the issuance of the distinctive license plate on a monthly basis.

11 **Sec. 4. K.S.A. 2011 Supp. 8-1,142 is hereby amended to read as**
12 **follows: 8-1,142. (a) As used in this section, "educational institution"**
13 **means:**

14 **(1) Any state educational institution under the control and**
15 **supervision of the state board of regents;**

16 **(2) any municipal university;**

17 **(3) any not-for-profit independent institution of higher education**
18 **which is accredited by the north central association of colleges and**
19 **secondary schools accrediting agency based on its requirements as of**
20 **April 1, 1985, is operated independently and not controlled or**
21 **administered by the state or any agency or subdivision thereof,**
22 **maintains open enrollment and the main campus or principal place of**
23 **operation of which is located in Kansas;**

24 **(4) any community college organized and operating under the laws**
25 **of this state; and**

26 **(5) Haskell Indian Nations university.**

27 **(b) Any owner or lessee of one or more passenger vehicles or trucks**
28 **registered for a gross weight of not more than 20,000 pounds who is a**
29 **resident of Kansas, upon compliance with the provisions of this section,**
30 **may be issued one educational institution license plate for each such**
31 **passenger vehicle or truck. Such license plates shall be issued for the**
32 **same period of time as other license plates upon proper registration and**
33 **payment of the regular license fee as provided in K.S.A. 8-143, and**
34 **amendments thereto, plus the payment of an additional fee of \$5 for**
35 **each plate, and the presentation of the annual emblem use authorization**
36 **statement provided for in subsection (c). Presentation of the annual**
37 **emblem use authorization statement shall not be required by the county**
38 **treasurer if the emblem use royalty payment is paid to the county treasurer.**

39 **(c) Any educational institution may authorize through its officially**
40 **recognized alumni association or foundation the use of such**
41 **institution's official emblems to be affixed on license plates as provided**
42 **by this section. Any royalty payment to such alumni association or**
43 **foundation or county treasurer derived from this section, except**

1 *reasonable administrative costs, shall be used for recognition of*
2 *academic achievement or excellence subject to the approval of the*
3 *chancellor or president of the educational institution. Any motor vehicle*
4 *owner or lessee may annually apply to the alumni association or,*
5 *foundation or county treasurer for the use of the institution's emblems.*
6 *Upon annual application and payment to the alumni association or*
7 *foundation or county treasurer in an amount of not less than \$25 nor*
8 *more than \$100 as an emblem use royalty payment for each educational*
9 *institution license plate to be issued, the alumni association or*
10 *foundation shall issue to the motor vehicle owner or lessee, without*
11 *further charge, an emblem use authorization statement, which shall be*
12 *presented by the motor vehicle owner or lessee at the time of*
13 *registration. Presentation of the annual emblem use authorization*
14 *statement shall not be required by the county treasurer if the emblem use*
15 *royalty payment is paid to the county treasurer.*

16 *(d) Any applicant for an educational institution license plate may*
17 *make application for such plates not less than 60 days prior to such*
18 *person's renewal of registration date, on a form prescribed and*
19 *furnished by the director of vehicles, and any applicant for the*
20 *educational institution license plates shall provide the annual emblem*
21 *use authorization statement provided for in subsection (c). Application*
22 *for registration of a passenger vehicle or truck and issuance of the*
23 *license plates under this section shall be made by the owner or lessee in*
24 *a manner prescribed by the director of vehicles upon forms furnished by*
25 *the director.*

26 *(e) No registration or educational institution license plate issued*
27 *under this section shall be transferable to any other person.*

28 *(f) The director of vehicles may transfer educational institution*
29 *license plates from a leased vehicle to a purchased vehicle.*

30 *(g) Renewals of registration under this section shall be made*
31 *annually, upon payment of the fee prescribed in subsection (b), in the*
32 *manner prescribed in subsection (b) of K.S.A. 8-132, and amendments*
33 *thereto. No renewal of registration shall be made to any applicant until*
34 *such applicant either provides the annual emblem use authorization*
35 *statement provided for in subsection (c) or makes the annual emblem use*
36 *royalty payment directly to the county treasurer. If such emblem use*
37 *authorization statement is not presented at the time of registration or*
38 *faxed by the alumni association or foundation, or the annual emblem use*
39 *royalty payment is not made to the county treasurer, the applicant shall be*
40 *required to comply with K.S.A. 8-143, and amendments thereto, and*
41 *return the educational institution license plates to the county treasurer*
42 *of such person's residence.*

43 *(g)(h) The director of vehicles shall not issue any educational*

1 *institution license plates for any educational institution, unless such*
2 *educational institution's alumni association or foundation guarantees*
3 *the initial issuance of at least 500 license plates.*

4 ~~(i)~~ *(i) The director of vehicles shall discontinue the issuance of an*
5 *educational institution's license plate authorized under this section if:*

6 *(1) Less than 500 educational institution license plates, including*
7 *annual renewals, are issued for an educational institution by the end of*
8 *the second year of sales; and*

9 *(2) less than 250 educational institution license plates, including*
10 *annual renewals, are issued for an educational institution during any*
11 *subsequent two-year period.*

13 *foundation shall:*

15 *license plates; and*

18 *information concerning the application process or the status of their*
19 *license plate application.*

21 *foundation, with the approval of the director of vehicles and subject to*
22 *the availability of materials and equipment, shall design a license plate*
23 *to be issued under the provisions of this section.*

24 *(l) As a condition of receiving the educational institution license plate*
25 *and any subsequent registration renewal of such plate, the applicant must*
26 *provide consent to the division authorizing the division's release of motor*
27 *vehicle record information, including the applicant's name, address,*
28 *emblem use royalty payment amount, plate number and vehicle type to the*
29 *relevant educational institution and the state treasurer.*

30 *(m) Annual royalty payments collected by county treasurers under*
31 *this section shall be remitted to the state treasurer in accordance with the*
32 *provisions of K.S.A. 75-4215, and amendments thereto. In the case of an*
33 *educational institution that is a state educational institution as defined by*
34 *K.S.A. 76-711, and amendments thereto, upon receipt of each such*
35 *remittance, the state treasurer shall deposit the entire amount in the state*
36 *treasury to the credit of the appropriate account of the restricted fees fund*
37 *of such state educational institution. In the case of an educational*
38 *institution which is not a state educational institution as defined by K.S.A.*
39 *76-711, and amendments thereto, upon receipt of each such remittance,*
40 *the state treasurer shall remit the entire amount to the educational*
41 *institutions emblem royalty fund, which is hereby created in the state*
42 *treasury and shall be administered by the state treasurer. All expenditures*
43 *from the educational institutions emblem royalty fund shall be made in*

1 accordance with appropriation acts upon warrants of the director of
2 accounts and reports issued pursuant to vouchers approved by the state
3 treasurer or the state treasurer's designee. Payments from the educational
4 institutions emblem royalty fund to the respective educational institutions
5 shall be made on a monthly basis.

28 **amendments thereto. Any motor vehicle owner or lessee may annually**
