12 *Be it enacted by the Legislature of the State of Kansas:*

13 *New Section. 1. (a) A license for a public venue shall allow the*
14 *licensee to:*

15 *(1) Offer for sale, sell and serve alcoholic liquor by the individual*
16 *drink for consumption on the licensed premises;*

17 *(2) offer for sale, sell and serve unlimited drinks for a fixed price in*
18 *designated areas of the licensed premises;*

19 *(3) offer for sale and sell all inclusive packages which include*
20 *unlimited drinks in designated areas of the licensed premises;*

21 *(4) offer for sale, sell and serve alcoholic liquor in the original*
22 *container for consumption on the licensed premises in private suites,*
23 *which are enclosed or semi-enclosed seating areas, having controlled*
24 *access and separated from the general admission areas by a permanent*
25 *barrier;*

26 *(5) store, in each private suite, which are enclosed or semi-enclosed*
27 *seating areas, having controlled access and separated from the general*
28 *admission areas by a permanent barrier, alcoholic liquor sold in the*
29 *original container to a customer in that private suite; and*

30 *(6) with the approval of the retailer or distributor, return for a full*
31 *refund of the original purchase price unopened containers of alcoholic*
32 *liquor to the retailer or distributor from whom such items were*
33 *purchased upon the conclusion of an event if the next scheduled event*
34 *for that premises is more than 90 days from the date of the concluded*
35 *event.*

36 *(b) An applicant or public venue licensee shall specify in the*

1 *application for a license, or renewal of a license, the premises to be*
2 *licensed, which may include all premises which are in close proximity*
3 *and are under the control of the applicant or licensee. No public venue*
4 *licensee may offer for sale, sell or serve any alcoholic liquor in any area*
5 *not included in the licensed premises.*

6 *New Sec. 2. (a) A microdistillery license shall allow:*

7 *(1) The manufacture of not more than 50,000 gallons of spirits per*
8 *year and the storage thereof;*

9 *(2) the sale to spirit distributors of spirits, manufactured by the*
10 *licensee;*

11 *(3) the sale, on the licensed premises in the original unopened*
12 *container to consumers for consumption off the licensed premises, of*
13 *spirits manufactured by the licensee;*

14 *(4) the serving free of charge on the licensed premises and at*
15 *special events, monitored and regulated by the division of alcoholic*
16 *beverage control, of samples of spirits manufactured by the licensee, if*
17 *the premises are located in a county where the sale of alcoholic liquor is*
18 *permitted by law in licensed drinking establishments;*

19 *(5) if the licensee is also licensed as a club or drinking*
20 *establishment, the sale of spirits and other alcoholic liquor for*
21 *consumption on the licensed premises as authorized by the club and*
22 *drinking establishment act; and*

23 *(6) if the licensee is also licensed as a caterer, the sale of spirits and*
24 *other alcoholic liquor for consumption on unlicensed premises as*
25 *authorized by the club and drinking establishment act.*

26 *(b) Upon application and payment of the fee prescribed by K.S.A.*
27 *41-310, and amendments thereto, by a microdistillery licensee, the*
28 *director may issue not to exceed one microdistillery packaging and*
29 *warehousing facility license to the microdistillery licensee. A*
30 *microdistillery packaging and warehousing facility license shall allow:*

31 *(1) The transfer, from the licensed premises of the microdistillery to*
32 *the licensed premises of the microdistillery packaging and warehousing*
33 *facility, of spirits manufactured by the licensee, for the purpose of*
34 *packaging or storage, or both;*

35 *(2) the transfer, from the licensed premises of the microdistillery*
36 *packaging and warehousing facility to the licensed premises of the*
37 *microdistillery, of spirits manufactured by the licensee; or*

38 *(3) the removal from the licensed premises of the microdistillery*
39 *packaging and warehousing facility of spirits manufactured by the*
40 *licensee for the purpose of delivery to a licensed spirits wholesaler.*

41 *(c) A microdistillery may sell spirits in the original unopened*
42 *container to consumers for consumption off the licensed premises at any*
43 *time between 6 a.m. and 12 midnight on any day except Sunday and*

1 *between 11 a.m. and 7 p.m. on Sunday. If authorized by subsection (a), a*
2 *microdistillery may serve samples of spirits and serve and sell spirits and*
3 *other alcoholic liquor for consumption on the licensed premises at any*
4 *time when a club or drinking establishment is authorized to serve and*
5 *sell alcoholic liquor.*

6 *(d) The director may issue to the Kansas state fair or any bona fide*
7 *group of distillers a permit to import into this state small quantities of*
8 *spirits. Such spirits shall be used only for bona fide educational and*
9 *scientific tasting programs and shall not be resold. Such spirits shall not*
10 *be subject to the tax imposed by K.S.A. 41-501, and amendments thereto.*
11 *The permit shall identify specifically the brand and type of spirit to be*
12 *imported, the quantity to be imported, the tasting programs for which the*
13 *spirit is to be used and the times and locations of such programs. The*
14 *secretary shall adopt rules and regulations governing the importation of*
15 *spirits pursuant to this subsection and the conduct of tasting programs*
16 *for which such spirits are imported.*

17 *(e) A microdistillery license or microdistillery packaging and*
18 *warehousing facility license shall apply only to the premises described in*
19 *the application and in the license issued and only one location shall be*
20 *described in the license.*

21 *(f) No microdistillery shall:*

22 *(1) Employ any person under the age of 18 years in connection with*
23 *the manufacture, sale or serving of any alcoholic liquor;*

24 *(2) permit any employee of the licensee who is under the age of 17*
25 *years to work on the licensed premises at any time when not under the*
26 *on-premises supervision of either the licensee or an employee of the*
27 *licensee who is 21 years of age or over;*

28 *(3) employ any person under 21 years of age in connection with*
29 *mixing or dispensing alcoholic liquor; or*

30 *(4) employ any person in connection with the manufacture or sale*
31 *of alcoholic liquor if the person has been convicted of a felony.*

32 *(g) Whenever a microdistillery licensee is convicted of a violation of*
33 *the Kansas liquor control act, the director may revoke the licensee's*
34 *license and all fees paid for the license in accordance with the Kansas*
35 *administrative procedure act.*

36 *New Sec. 3. (a) Notwithstanding any other provisions of the Kansas*
37 *liquor control act to the contrary, any person or entity who is licensed to*
38 *sell alcoholic liquor in the original package at retail may conduct wine,*
39 *beer and distilled spirit tastings on the licensed premises, or adjacent*
40 *premises, monitored and regulated by the division of alcoholic beverage*
41 *control, as follows:*

42 *(1) Wine, beer and spirits for the tastings shall come from the*
43 *inventory of the licensee. Except as provided by paragraph (2), a person*

1 *other than the licensee or the licensee's agent or employee may not*
2 *dispense or participate in the dispensing of alcoholic beverages under*
3 *this section.*

4 (2) *The holder of a supplier's permit or such permit holder's agent*
5 *or employee may participate in and conduct product tastings of alcoholic*
6 *beverages at a retail licensee's premises, or adjacent premises,*
7 *monitored and regulated by the division of alcoholic beverage control,*
8 *and may open, touch, or pour alcoholic beverages, make a presentation,*
9 *or answer questions at the tasting. Any alcoholic beverage tasted under*
10 *this subsection must be purchased from the retailer on whose premises*
11 *the tasting is held. The retailer may not require the purchase of more*
12 *alcoholic beverages than are necessary for the tasting. This section does*
13 *not authorize the supplier or its agent to withdraw or purchase an*
14 *alcoholic beverage from the holder of a distributor's permit or provide*
15 *an alcoholic beverage for tasting on a retailer's premises that is not*
16 *purchased from the retailer.*

17 (3) *Sample portions at a product tasting shall be limited to no more*
18 *than:*

19 (A) *One-half ounce for distilled spirits;*

20 (B) *one ounce for wine; and*

21 (C) *two ounces for beer and malt beverages.*

22 (4) *No charge of any sort may be made for a sample serving.*

23 (5) *A person may be served more than one sample. Samples may*
24 *not be served to a minor. No samples may be removed from the licensed*
25 *premises.*

26 (6) *The act of providing samples to consumers shall be exempt from*
27 *the requirement of holding a Kansas food service dealer license from the*
28 *department of agriculture under the provisions of chapter 65 of the*
29 *Kansas Statutes Annotated, and amendments thereto.*

30 (b) *Nothing in this section shall be construed to permit the licensee*
31 *to sell wine, malt beverages or distilled spirits for on-premises*
32 *consumption.*

33 *Sec. 4. K.S.A. 2011 Supp. 41-102 is hereby amended to read as*
34 *follows: 41-102. As used in this act, unless the context clearly requires*
35 *otherwise:*

36 (a) *"Alcohol" means the product of distillation of any fermented*
37 *liquid, whether rectified or diluted, whatever its origin, and includes*
38 *synthetic ethyl alcohol but does not include denatured alcohol or wood*
39 *alcohol.*

40 (b) *"Alcoholic liquor" means alcohol, spirits, wine, beer and every*
41 *liquid or solid, patented or not, containing alcohol, spirits, wine or beer*
42 *and capable of being consumed as a beverage by a human being, but*
43 *shall not include any cereal malt beverage.*

1 (c) *"Beer" means a beverage, containing more than 3.2% alcohol*
2 *by weight, obtained by alcoholic fermentation of an infusion or*
3 *concoction of barley, or other grain, malt and hops in water and*
4 *includes beer, ale, stout, lager beer, porter and similar beverages having*
5 *such alcoholic content.*

6 (d) *"Caterer" has the meaning provided by K.S.A. 41-2601, and*
7 *amendments thereto.*

8 (e) *"Cereal malt beverage" has the meaning provided by K.S.A. 41-*
9 *2701, and amendments thereto.*

10 (f) *"Club" has the meaning provided by K.S.A. 41-2601, and*
11 *amendments thereto.*

12 (g) *"Director" means the director of alcoholic beverage control of*
13 *the department of revenue.*

14 (h) *"Distributor" means the person importing or causing to be*
15 *imported into the state, or purchasing or causing to be purchased within*
16 *the state, alcoholic liquor for sale or resale to retailers licensed under*
17 *this act or cereal malt beverage for sale or resale to retailers licensed*
18 *under K.S.A. 41-2702, and amendments thereto.*

19 (i) *"Domestic beer" means beer which contains not more than 10%*
20 *alcohol by weight and which is manufactured in this state.*

21 (j) *"Domestic fortified wine" means wine which contains more*
22 *than 14%, but not more than 20% alcohol by volume and which is*
23 *manufactured in this state.*

24 (k) *"Domestic table wine" means wine which contains not more*
25 *than 14% alcohol by volume and which is manufactured without*
26 *rectification or fortification in this state.*

27 (l) *"Drinking establishment" has the meaning provided by K.S.A.*
28 *41-2601, and amendments thereto.*

29 (m) *"Farm winery" means a winery licensed by the director to*
30 *manufacture, store and sell domestic table wine and domestic fortified*
31 *wine.*

32 (n) *"Manufacture" means to distill, rectify, ferment, brew, make,*
33 *mix, concoct, process, blend, bottle or fill an original package with any*
34 *alcoholic liquor, beer or cereal malt beverage.*

35 (o) (1) *"Manufacturer" means every brewer, fermenter, distiller,*
36 *rectifier, wine maker, blender, processor, bottler or person who fills or*
37 *refills an original package and others engaged in brewing, fermenting,*
38 *distilling, rectifying or bottling alcoholic liquor, beer or cereal malt*
39 *beverage.*

40 (2) *"Manufacturer" does not include a microbrewery,*
41 *microdistillery or a farm winery.*

42 (p) *"Microbrewery" means a brewery licensed by the director to*
43 *manufacture, store and sell domestic beer.*

1 (q) *"Microdistillery" means a facility which produces spirits from any*
2 *source or substance that is licensed by the director to manufacture, store*
3 *and sell spirits.*

4 ~~(r)~~(r) *"Minor" means any person under 21 years of age.*

5 ~~(s)~~(s) *"Nonbeverage user" means any manufacturer of any of the*
6 *products set forth and described in K.S.A. 41-501, and amendments*
7 *thereto, when the products contain alcohol or wine, and all laboratories*
8 *using alcohol for nonbeverage purposes.*

9 ~~(t)~~(t) *"Original package" means any bottle, flask, jug, can, cask,*
10 *barrel, keg, hogshead or other receptacle or container whatsoever, used,*
11 *corked or capped, sealed and labeled by the manufacturer of alcoholic*
12 *liquor, to contain and to convey any alcoholic liquor. Original container*
13 *does not include a sleeve.*

14 ~~(u)~~(u) *"Person" means any natural person, corporation,*
15 *partnership, trust or association.*

16 ~~(v)~~(v) *"Primary American source of supply" means the*
17 *manufacturer, the owner of alcoholic liquor at the time it becomes a*
18 *marketable product or the manufacturer's or owner's exclusive agent*
19 *who, if the alcoholic liquor cannot be secured directly from such*
20 *manufacturer or owner by American wholesalers, is the source closest to*
21 *such manufacturer or owner in the channel of commerce from which*
22 *the product can be secured by American wholesalers.*

23 ~~(w)~~(w) (1) *"Retailer" means a person who sells at retail, or offers*
24 *for sale at retail, alcoholic liquors.*

25 (2) *"Retailer" does not include a microbrewery, microdistillery or a*
26 *farm winery.*

27 ~~(x)~~(x) *"Sale" means any transfer, exchange or barter in any*
28 *manner or by any means whatsoever for a consideration and includes all*
29 *sales made by any person, whether principal, proprietor, agent, servant*
30 *or employee.*

31 ~~(y)~~(y) *"Salesperson" means any natural person who:*

32 (1) *Procures or seeks to procure an order, bargain, contract or*
33 *agreement for the sale of alcoholic liquor or cereal malt beverage; or*

34 (2) *is engaged in promoting the sale of alcoholic liquor or cereal*
35 *malt beverage, or in promoting the business of any person, firm or*
36 *corporation engaged in the manufacturing and selling of alcoholic*
37 *liquor or cereal malt beverage, whether the seller resides within the state*
38 *of Kansas and sells to licensed buyers within the state of Kansas, or*
39 *whether the seller resides without the state of Kansas and sells to*
40 *licensed buyers within the state of Kansas.*

41 ~~(z)~~(z) *"Secretary" means the secretary of revenue.*

42 ~~(aa)~~(aa) (1) *"Sell at retail" and "sale at retail" refer to and mean*
43 *sales for use or consumption and not for resale in any form and sales to*

1 *clubs, licensed drinking establishments, licensed caterers or holders of*
2 *temporary permits.*

3 (2) *"Sell at retail" and "sale at retail" do not refer to or mean sales*
4 *by a distributor, a microbrewery, a farm winery, a licensed club, a*
5 *licensed drinking establishment, a licensed caterer or a holder of a*
6 *temporary permit.*

7 ~~(aa)~~(bb) *"To sell" includes to solicit or receive an order for, to keep*
8 *or expose for sale and to keep with intent to sell.*

9 ~~(bb)~~(cc) *"Sleeve" means a package of two or more 50-milliliter*
10 *(3.2-fluid-ounce) containers of spirits.*

11 ~~(ee)~~(dd) *"Spirits" means any beverage which contains alcohol*
12 *obtained by distillation, mixed with water or other substance in solution,*
13 *and includes brandy, rum, whiskey, gin or other spirituous liquors, and*
14 *such liquors when rectified, blended or otherwise mixed with alcohol or*
15 *other substances.*

16 ~~(dd)~~(ee) *"Supplier" means a manufacturer of alcoholic liquor or*
17 *cereal malt beverage or an agent of such manufacturer, other than a*
18 *salesperson.*

19 ~~(ee)~~(ff) *"Temporary permit" has the meaning provided by K.S.A.*
20 *41-2601, and amendments thereto.*

21 ~~(ff)~~(gg) *"Wine" means any alcoholic beverage obtained by the*
22 *normal alcoholic fermentation of the juice of sound, ripe grapes, fruits,*
23 *berries or other agricultural products, including such beverages*
24 *containing added alcohol or spirits or containing sugar added for the*
25 *purpose of correcting natural deficiencies.*

26 *Sec. 5. K.S.A. 41-304 is hereby amended to read as follows: 41-304.*
27 *Licenses issued by the director shall be of the following classes: (a)*
28 *Manufacturer's license; (b) spirits distributor's license; (c) wine*
29 *distributor's license; (d) beer distributor's license; (e) retailer's license;*
30 *(f) microbrewery license; (g) microdistillery license; (h) farm winery*
31 *license; and ~~(h)~~(i) nonbeverage user's license.*

32 *Sec. 6. K.S.A. 2011 Supp. 41-305 is hereby amended to read as*
33 *follows: 41-305. (a) A manufacturer's license shall allow the*
34 *manufacture and storage of alcoholic liquor and cereal malt beverage*
35 *and the sale of alcoholic liquor and cereal malt beverage to distributors*
36 *and nonbeverage users licensed in this state and to such persons outside*
37 *this state as permitted by law.*

39 *charge on the licensed premises of samples of alcoholic liquor*

16 *spirits distributor may purchase confiscated spirits at a sheriff's sale.*

35 *amendments thereto, on the distributor's licensed premises, of alcoholic*
36 *liquor or cereal malt beverage of another licensed distributor authorized*
37 *by law to sell such alcoholic liquor or cereal malt beverage to such*
38 *retailer, in accordance with an agreement entered into with such other*
39 *distributor and approved by the director.*

40 *(e) The storage and delivery to a public venue licensed under the*
41 *club and drinking establishment act of alcoholic liquor purchased by the*
42 *public venue licensee from a retailer authorized by law to sell such*
43 *alcoholic liquor to such public venue licensee.*

3 **(a) The wholesale purchase, importation and storage of wine, but**
4 **all wine so purchased or imported which is manufactured in the United**
5 **States shall be purchased from the primary American source of supply**
6 **or from another licensed wine distributor, except that a licensed wine**
7 **distributor may purchase confiscated wine at a sheriff's sale.**

8 **(b) The sale of wine to:**

9 **(1) Wine distributors licensed in this state;**

10 **(2) retailers licensed in this state, except that such distributor shall**
11 **sell a brand of wine only to those retailers whose licensed premises are**
12 **located in the geographic territory within which such distributor is**
13 **authorized to sell such brand, as designated in the notice or notices filed**
14 **with the director pursuant to K.S.A. 41-410, and amendments thereto;**

16 **(3) such persons located outside such territory or outside this state**

22 **state, except that such distributor shall sell a brand of wine only to such**
23 **public venues, clubs and drinking establishments the licensed premises**
24 **of which are located in the geographic territory within which such**
25 **distributor is authorized to sell such brand, as designated in the notice or**
26 **notices filed with the director pursuant to K.S.A. 41-410, and**
27 **amendments thereto.**

28 **(d) The purchase of wine in barrels, casks or other bulk containers**
29 **and the bottling thereof before resale, but all bottles or containers filled**
30 **with such wine shall be sealed, labeled and otherwise made to comply**
31 **with all laws and rules and regulations governing the preparation and**
32 **bottling of wine by manufacturers and with all federal rules, regulations**
33 **and laws.**

34 **(e) The storage and delivery to a retailer licensed under the Kansas**
35 **liquor control act or a retailer licensed under K.S.A. 41-2702, and**
36 **amendments thereto, on the distributor's licensed premises, of alcoholic**
37 **liquor or cereal malt beverage of another licensed distributor authorized**
38 **by law to sell such alcoholic liquor or cereal malt beverage to such**
39 **retailer, in accordance with an agreement entered into with such other**
40 **distributor and approved by the director.**

41 **(f) This section shall be part of and supplemental to the Kansas**
42 **liquor control act.**

1 *A beer distributor's license shall allow:*

2 *(a) The wholesale purchase, importation and storage of beer.*

3 *(b) The sale of beer to:*

4 *(1) Licensed caterers;*

5 *(2) beer distributors licensed in this state;*

6 *(3) retailers, public venues, clubs and drinking establishments,*
7 *licensed in this state, except that such distributor shall sell a brand of*
8 *beer only to those retailers, public venues, clubs and drinking*
9 *establishments of which the licensed premises are located in the*
10 *geographic territory within which such distributor is authorized to sell*
11 *such brand, as designated in the notice or notices filed with the director*
12 *pursuant to K.S.A. 41-410, and amendments thereto; and*

13 *(4) such persons located outside such territory or outside this state*
14 *as permitted by law.*

15 *(c) The sale of cereal malt beverage to:*

16 *(1) Beer distributors licensed in this state;*

17 *(2) clubs and drinking establishments, licensed in this state, and*
18 *retailers licensed under K.S.A. 41-2702, and amendments thereto, except*
19 *that such distributor shall sell a brand of cereal malt beverage only to*
20 *those such clubs, drinking establishments and retailers of which the*
21 *licensed premises are located in the geographic territory within which*
22 *such distributor is authorized to sell such brand, as designated in the*
23 *notice or notices filed with the director pursuant to K.S.A. 41-410, and*
24 *amendments thereto; and*

25 *(3) such persons located outside such territory or outside this state*
26 *as permitted by law.*

12 any moneys distributed under this section, shall deposit the full amount in

15 1/3 to a special alcohol and drug programs fund in the city treasury. Each
16 city treasurer of a city that has a population of 6,000 or less, upon receipt
17 of any moneys distributed under this section, shall deposit the full amount
18 in the city treasury and shall credit 1/2 of the deposit to the general fund of
19 the city and 1/2 to a special parks and recreation fund in the city treasury.
20 Moneys in such special funds shall be under the direction and control of
21 the governing body of the city. Moneys in the special parks and recreation
22 fund may be expended only for the purchase, establishment, maintenance
23 or expansion of park and recreational services, programs and facilities.
24 One-half of the moneys distributed under this section to cities located in
25 Butler county shall be deposited in a special community support program
26 and parks and recreation fund in the city treasury. Moneys in the special
27 community support program and parks and recreation fund may be

29 violence program operated by a not-for-profit organization or (2) the
30 purchase, establishment, maintenance or expansion of park and
31 recreational services, programs and facilities. Moneys in the special
32 alcohol and drug programs fund shall be expended only for the purchase,
33 establishment, maintenance or expansion of services or programs whose
34 principal purpose is alcoholism and drug abuse prevention and education,
35 alcohol and drug detoxification, intervention in alcohol and drug abuse or
36 treatment of persons who are alcoholics or drug abusers or are in danger of
37 becoming alcoholics or drug abusers.

38 (e) Except as otherwise provided by this subsection, each county
39 treasurer, upon receipt of any moneys distributed under this section, shall
40 deposit the full amount in the county treasury and shall credit to a special
41 alcohol and drug programs fund in the county treasury 23 1/3% of the
42 amount which is collected pursuant to this act from clubs or drinking
43 establishments located in the county and within a city that has a population

1 of 6,000 or less, from caterers whose principal place of business is so
2 located or from temporary permit holders whose permitted events are so
3 located and which is paid into the state treasury during the period for
4 which the allocation is made; of the remainder, the treasurer shall credit
5 1/3 to the general fund of the county, 1/3 to a special parks and recreation
6 fund in the county treasury and 1/3 to the special alcohol and drug
7 programs fund. Moneys in such special funds shall be under the direction
8 and control of the board of county commissioners. Moneys in the special
9 parks and recreation fund may be expended only for the purchase,
10 establishment, maintenance or expansion of park and recreational services,
11 programs and facilities. One-third of the moneys distributed under this
12 section to Butler county shall be deposited in a special community support
13 program and parks and recreation fund in the county treasury. Moneys in
14 the special community support program and parks and recreation fund may
15 be expended only for (1) the establishment and operation of a domestic
16 violence program operated by a not-for-profit organization or (2) the
17 purchase, establishment, maintenance or expansion of park and
18 recreational services, programs and facilities. Moneys in the special
19 alcohol and drug programs fund shall be expended only for the purchase,
20 establishment, maintenance or expansion of services or programs whose
21 principal purpose is alcoholism and drug abuse prevention and education,
22 alcohol and drug detoxification, intervention in alcohol and drug abuse or
23 treatment of persons who are alcoholics or drug abusers or are in danger of

25 been organized an alcohol and drug advisory committee, the board of
26 county commissioners shall request and obtain, prior to making any
27 expenditures from the special alcohol and drug programs fund, the
28 recommendations of the advisory committee concerning such
29 expenditures. The board of county commissioners shall adopt the
30 recommendations of the advisory committee concerning such expenditures
31 unless the board, by unanimous vote of all commissioners, adopts a
32 different plan for such expenditures.

33 (f) Each year, the county treasurer shall estimate the amount of
34 money the county and each city in the county will receive from the local
35 alcoholic liquor fund and from distributions pursuant to K.S.A. 79-41a05,
36 and amendments thereto. The state treasurer shall advise each county
37 treasurer, prior to June 1 of each year of the amount in the local alcoholic
38 liquor fund that the state treasurer estimates, using the most recent
39 available information, will be allocated to such county in the following
40 year. The county treasurer shall, before June 15 of each year, notify the
41 treasurer of each city of the estimated amount in dollars of the distribution
42 to be made from the local alcoholic liquor fund and pursuant to K.S.A. 79-
43 41a05, and amendments thereto.
