AN ACT establishing the Kansas employment first initiative act and 1 2 creating the Kansas employment first oversight commission. 3 4 Be it enacted by the Legislature of the State of Kansas: 5 Section 1. (a) This act shall be known as and cited as the Kansas employment first initiative act. 6 (b) It is hereby declared to be the policy of the state of Kansas that 7 competitive and integrated employment shall be considered its first 8 option when serving persons with disabilities who are of working age to 9 10 obtain employment for state employment and for those entities that contract with state agencies to provide employment for persons with a 11 12 disability. This policy applies to programs and services that support the employment of persons with disabilities. All state agencies shall follow 13 this policy and ensure that it is effectively implemented in their programs 14 and services 15 16 Sec. 2. (a) All state agencies shall coordinate efforts and shall 17 collaborate within and among such agencies to ensure that state programs, policies, procedures and funding support competitive and 18 integrated employment of individuals with disabilities. All state agencies 19 shall, whenever feasible, share data and information across systems in 20 21 order to track progress toward full implementation of the act. 22 (b) State agencies are authorized to adopt rules and regulations to 23 implement this act. 24 Sec. 3. (a) There is hereby established a Kansas employment first 25 oversight commission consisting of five members. The commission shall 26 consist of the following members who shall serve a for two-year term: 27 (1) Four members who are persons with a disability or who are knowledgeable of disability issues and who are not state employees, of 28 29 whom. (A) One shall be appointed by the speaker of the house of 30 31 representatives; 32 one shall be appointed by the minority leader of the house of (B) representatives; 33 34 (C) one shall be appointed by the president of the senate; and one shall be appointed by the minority leader of the senate; 35 (D) 36 (2) one member who is experienced with employment service

1 programs and who is not a state employee shall be appointed by the 2 governor.

(b) The governor shall designate one member to convene and
organize the first meeting of the commission at which the commission
shall elect a chairperson and a vice-chairperson from among its members.
The commission shall meet at least four times a year and, additionally,
whenever called by the chairperson. A quorum shall consist of three
members. All actions of the commission shall be taken by a majority of
the members of the commission.

10 (c) Each member of the commission shall be paid mileage and other 11 expenses as provided by K.S.A. 75-3212, and amendments thereto.

12 (d) The commission shall establish measurable goals and objectives 13 for the state of Kansas to ensure implementation of this act. The 14 commission shall track the measurable progress of public agencies in 15 implementing this act. All state agencies shall fully cooperate with and 16 provide data and information to assist the commission in carrying out its 17 duties.

18 (e) The commission shall issue an annual report on or before January 19 1 each year which shall be presented to the governor and members of the state legislature. The report shall detail progress toward the goals and 20 objectives and full implementation of this act. All state agencies shall 21 cooperate with the commission on the creation and dissemination of the 22 annual report. The report also shall identify barriers to achieving the 23 outcomes along with the effective strategies and policies that can help 24 realize the employment first initiative. 25

(f) The department of social and rehabilitation services shall be the
lead agency responsible for compiling data and coordinating the
preparation of the annual report at the direction of the commission.

(g) The provisions of section 3, and amendments thereto, shall expireon July 1, 2014.

31 Sec. 4. This act shall take effect and be in force from and after its 32 publication in the statute book.
