1 AN ACT concerning congressional districts; providing for the redistricting  
2 thereof; repealing K.S.A. 2011 Supp. 4-136, 4-137, 4-138, 4-139, 4-  
3 140, 4-141 and 4-142.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. (a) As used in sections 1 through 7, and amendments  
7 thereto, "voting district," "tract," "block group" or "block" means,  
8 respectively, a voting district (VTD), tract, block group or block identified  
9 on the official United States 2010 decennial census maps.

10 (b) Voting districts, tracts, block groups and blocks are referred to in  
11 sections 1 through 7, and amendments thereto, by the alphanumeric code  
12 by which they are identified on the official United States 2010 decennial  
13 census maps and data lists.

14 (c) The boundaries of counties, voting districts, tracts, block groups  
15 and blocks referred to in sections 1 through 7, and amendments thereto,  
16 are those boundaries as they exist and are identified on the official United  
17 States 2010 decennial census maps.

18 Sec. 2. (a) If a county, voting district, tract, block group or block is  
19 not included within a congressional district established by this act, such  
20 county, voting district, tract, block group or block shall be attached to the  
21 congressional district to which it is contiguous and, if contiguous to more  
22 than one congressional district, it shall be attached to the contiguous  
23 congressional district which has the least total population.

24 (b) If a county, voting district, tract, block group or block is included  
25 in two or more congressional districts established by this act, such county,  
26 voting district, tract, block group or block shall be attached to and become  
27 a part of the congressional district which has the least total population.

28 Sec. 3. The provisions of this act shall not affect the term of any  
29 representative to congress elected to represent a district at the general  
30 election of 2010 or the term of any successor elected to succeed such  
31 representative for an unexpired term, and all such representatives shall  
32 continue to serve the districts from which elected until the representatives  
33 elected from the congressional districts established by this act commence  
34 their terms of office in January of 2013.
