 AN ACT concerning congressional districts; providing for the redistricting thereof; repealing K.S.A. 2011 Supp. 4-136, 4-137, 4-138, 4-139, 4-140, 4-141 and 4-142.

Be it enacted by the Legislature of the State of Kansas:

Section 1. (a) As used in sections 1 through 7, and amendments
thereto, "voting district," "tract," "block group" or "block" means,
respectively, a voting district (VTD), tract, block group or block identified
on the official United States 2010 decennial census maps.

(b) Voting districts, tracts, block groups and blocks are referred to in
sections 1 through 7, and amendments thereto, by the alphanumeric code
by which they are identified on the official United States 2010 decennial
census maps and data lists.

(c) The boundaries of counties, voting districts, tracts, block groups
and blocks referred to in sections 1 through 7, and amendments thereto,
are those boundaries as they exist and are identified on the official United
States 2010 decennial census maps.

Sec. 2. (a) If a county, voting district, tract, block group or block is not included within a congressional district established by this act, such county, voting district, tract, block group or block shall be attached to the congressional district to which it is contiguous and, if contiguous to more than one congressional district, it shall be attached to the contiguous congressional district which has the least total population.

(b) If a county, voting district, tract, block group or block is included
in two or more congressional districts established by this act, such county,
voting district, tract, block group or block shall be attached to and become
a part of the congressional district which has the least total population.

Sec. 3. The provisions of this act shall not affect the term of any representative to congress elected to represent a district at the general election of 2010 or the term of any successor elected to succeed such representative for an unexpired term, and all such representatives shall continue to serve the districts from which elected until the representatives elected from the congressional districts established by this act commence their terms of office in January of 2013.
