


Exports Contribute to a Healthy Economy

- Each export brings in new dollars to Kansas.
- Exporting companies pay higher wages.
- Exports support over a third of manufacturing jobs.
- Smaller companies generate about 25% of the state's exports.
- Every \$1 billion in exports supports 6,000 American jobs.
- 2011 Kansas Exports supported 69,588 jobs

Kansas Export Profile

- Many industries contribute to Kansas total exports, but manufactured goods drive them.
- Manufactured goods (including durable & non-durable goods) makeup 86.45% of total (average 2007-11).
- Non-manufactured goods (agriculture products, oil, gas, minerals and ores) make up 15.40% of total (average 2007-11).
- Wichita MSA firms historically generate about 50% of state's exports.

• Wichita is the MOST EXPORT DEPENDENT METRO IN THE NATION — exports represent more than 20% of its gross metro product.



- Kansas exports rose to \$11.57 billion in 2011, an increase of 16.33% from 2010.
- Exports are flat from 2011-2012.
- Transportation equipment (airplanes and parts) decreased 45.2% from 2008-2009 and continues to decrease per annum. 2012 Performance in first three quarters of this year indicates another decrease from 2011.
- Ag exports are flat from 2011-2012.




Challenges for Kansas Exporters


- Lack of readily available information about exporting and market research




