1 AN ACT concerning school districts; relating to school finance; amending
2 K.S.A. 2012 Supp. 72-6448 and repealing the existing section.

4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. K.S.A. 2012 Supp. 72-6448 is hereby amended to read as
6 follows: 72-6448. (a) As used in this section:

7 (1) "Pupil" means a person who is a dependent of a full-time active
8 duty member of the military service or a dependent of a member of any of
9 the United States military reserve forces who has been ordered to active
10 duty under section 12301, 12302 or 12304 of Title 10 of the United States
11 Code, or ordered to full-time active duty for a period of more than 30
12 consecutive days under section 502(f) or 512 of Title 32 of the United
13 States Code for the purposes of mobilizing for war, international
14 peacekeeping missions, national emergency or homeland defense
15 activities.

16 (2) "School year" means school year ~~2009-2010, 2010-2011, 2011-~~
17 ~~2012 or 2012-2013~~ 2013-2014, 2014-2015, 2015-2016, 2016-2017 or
18 2017-2018.

19 (b) Each school year, the state board shall:

20 (1) Determine the number of pupils enrolled in each district on
21 September 20;

22 (2) determine the number of military pupils enrolled in each district
23 on February 20, who were not enrolled on the preceding September 20;

24 (c) (1) If the number obtained under (b)(2) is 25 or more, an amount
25 equal to the number obtained under (b)(2) shall be added to the number
26 determined under (b)(1). The sum is the enrollment of the district.

27 (2) If the number obtained under (b)(2) is at least 1% of the number
28 determined under (b)(1), an amount equal to the number obtained under
29 (b)(2) shall be added to the number determined under (b)(1). The sum is
30 the enrollment of the district.

1 (d) The state board shall recompute the adjusted enrollment of the
2 district and the general fund budget of the school district based on the
3 enrollment as determined under this section.

4 (e) Districts desiring to determine enrollment under this section shall
5 submit any documentation or information required by the state board.

6 Sec. 2. K.S.A. 2012 Supp. 72-6448 is hereby repealed.

7 Sec. 3. This act shall take effect and be in force from and after its
8 publication in the statute book.
