1 AN ACT concerning the criminal justice information system; relating to
2 electronically stored information; hearsay exception for official record,
3 authentication of record; amending K.S.A. 60-465 and K.S.A. 2015
4 Supp. 22-4701, 22-4705 and 60-460 and repealing the existing sections.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 2015 Supp. 22-4701 is hereby amended to read as
8 follows: 22-4701. As used in this act, unless the context clearly requires
9 otherwise:

10 (a) "Central repository" means the criminal justice information
11 system central repository created by this act and the juvenile offender
12 information system created pursuant to K.S.A. 2015 Supp. 38-2326, and
13 amendments thereto.

14 (b) "Criminal history record information" means all data initiated or
15 collected by a criminal justice agency on a person pertaining to a
16 reportable event, and any supporting documentation. Criminal history
17 record information does not include:

18 (1) Data contained in intelligence or investigatory files or police
19 work-product records used solely for police investigation purposes;

20 (2) wanted posters, police blotter entries, court records of public
21 judicial proceedings or published court opinions;

22 (3) data pertaining to violations of the traffic laws of the state or any
23 other traffic law or ordinance, other than vehicular homicide;

24 (4) presentence investigation and other reports prepared for use by a
25 court in the exercise of criminal jurisdiction or by the governor in the
26 exercise of the power of pardon, reprieve or commutation; or

27 (5) information regarding the release, assignment to work release, or
28 any other change in custody status of a person confined by the department
29 of corrections or a jail.

30 (c) "Criminal justice agency" means any government agency or
31 subdivision of any such agency which is authorized by law to exercise the
32 power of arrest, detention, prosecution, adjudication, correctional
33 supervision, rehabilitation or release of persons suspected, charged or
34 convicted of a crime and which allocates a substantial portion of its annual
35 budget to any of these functions. The term includes, but is not limited to,
36 the following agencies, when exercising jurisdiction over criminal matters

1 or criminal history record information:

2 (1) State, county, municipal and railroad police departments, sheriffs'
3 offices and countywide law enforcement agencies, correctional facilities,
4 jails and detention centers;

5 (2) the offices of the attorney general, county or district attorneys and
6 any other office in which are located persons authorized by law to
7 prosecute persons accused of criminal offenses;

8 (3) the district courts, the court of appeals, the supreme court, the
9 municipal courts and the offices of the clerks of these courts;

10 (4) the Kansas sentencing commission; and

11 (5) the prisoner review board.

12 (d) "Criminal justice information system" means the equipment,
13 including computer hardware and software, facilities, procedures,
14 agreements and personnel used in the collection, processing, preservation
15 and dissemination of criminal history record information *and any*
16 *electronically stored information from a state agency or municipality.*

17 (e) *"Electronically stored information" means any documents or*
18 *writings, drawings, graphs, charts, photographs, sound recordings,*
19 *images and other data or data compilations stored in any medium from*
20 *which information can be obtained either directly or, if necessary, after*
21 *translation from a state agency or municipality into a reasonably useable*
22 *form.*

23 (f) "Director" means the director of the Kansas bureau of
24 investigation.

25 ~~(f)~~ (g) "Disseminate" means to transmit criminal history record
26 information in any oral or written form. The term does not include:

27 (1) The transmittal of such information within a criminal justice
28 agency;

29 (2) the reporting of such information as required by this act; or

30 (3) the transmittal of such information between criminal justice
31 agencies in order to permit the initiation of subsequent criminal justice
32 proceedings against a person relating to the same offense.

33 ~~(g)~~ (h) "Reportable event" means an event specified or provided for
34 in K.S.A. 22-4705, and amendments thereto.

35 Sec. 2. K.S.A. 2015 Supp. 22-4705 is hereby amended to read as
36 follows: 22-4705. (a) The following events are reportable events under this
37 act:

38 (1) Issuance of an arrest warrant;

39 (2) an arrest;

40 (3) release of a person after arrest without the filing of a charge;

41 (4) the filing of a charge;

42 (5) dismissal or quashing of an indictment or criminal information;

43 (6) an acquittal, conviction or other disposition at or following trial,

1 including a finding of probation before judgment;

2 (7) imposition of a sentence;

3 (8) commitment to a correctional facility, whether state or locally
4 operated;

5 (9) release from detention or confinement;

6 (10) an escape from confinement;

7 (11) a pardon, reprieve, commutation of sentence or other change in a
8 sentence, including a change ordered by a court;

9 (12) judgment of an appellate court that modifies or reverses the
10 lower court decision;

11 (13) order of a court in a collateral proceeding that affects a person's
12 conviction, sentence or confinement, including any expungement or
13 annulment of arrests or convictions pursuant to state statute; and

14 (14) any other event arising out of or occurring during the course of
15 criminal justice proceedings declared to be reportable by rule or regulation
16 of the director.

17 (b) There is hereby established a criminal justice information system
18 central repository for the collection, storage, and dissemination of criminal
19 history record information *and any electronically stored information from*
20 *a state agency or municipality*. The central repository shall be operated by
21 the Kansas bureau of investigation under the administrative control of the
22 director.

23 (c) *The Kansas bureau of investigation may enter into an agreement*
24 *with any state agency or municipality to allow for the sharing and*
25 *authentication of any electronically stored information held by the state*
26 *agency or municipality, in whole or in part, to the central repository.*

27 (d) Except as otherwise provided by this subsection, every criminal
28 justice agency shall report criminal history record information, whether
29 collected manually or by means of an automated system, to the central
30 repository, in accordance with rules and regulations adopted pursuant to
31 this act. A criminal justice agency shall report to the central repository
32 those reportable events involving a violation of a county resolution or city
33 ordinance only when required by rules and regulations adopted by the
34 director.

35 ~~(d)~~ (e) Reporting methods may include:

36 (1) Submittal of criminal history record information by a criminal
37 justice agency directly to the central repository;

38 (2) if the information can readily be collected and reported through
39 the court system, submittal to the central repository by the administrative
40 office of the courts; ~~or~~

41 (3) if the information can readily be collected and reported through
42 criminal justice agencies that are part of a geographically based
43 information system, submittal to the central repository by the agencies; *or*

1 (4) *any transfer of electronically stored information by a state agency*
2 *or municipality to the central repository.*

3 ~~(e)~~ (f) Nothing in this section shall prevent a criminal justice agency
4 from maintaining more detailed information than is required to be reported
5 to the central repository. However, the dissemination of that criminal
6 history record information is governed by the provisions of this act.

7 ~~(f)~~ (g) The director may determine, by rule and regulation, the
8 reportable events to be reported by each criminal justice agency, in order
9 to avoid duplication in reporting.

10 ~~(g)~~ (h) Except as otherwise provided in this subsection, no court or
11 criminal justice agency may assess fees or charges against the central
12 repository for providing criminal history record information created prior
13 to, on or after July 1, 2011. A court or criminal justice agency may assess a
14 fee or charge against the central repository for providing criminal history
15 record information if such court or criminal justice agency has previously
16 provided such criminal history record information as required by law.

17 Sec. 3. K.S.A. 2015 Supp. 60-460 is hereby amended to read as
18 follows: 60-460. Evidence of a statement which is made other than by a
19 witness while testifying at the hearing, offered to prove the truth of the
20 matter stated, is hearsay evidence and inadmissible except:

21 (a) *Previous statements of persons present.* A statement previously
22 made by a person who is present at the hearing and available for cross-
23 examination with respect to the statement and its subject matter, provided
24 the statement would be admissible if made by declarant while testifying as
25 a witness.

26 (b) *Affidavits.* Affidavits, to the extent admissible by the statutes of
27 this state.

28 (c) *Depositions and prior testimony.* Subject to the same limitations
29 and objections as though the declarant were testifying in person; (1)
30 Testimony in the form of a deposition taken in compliance with the law of
31 this state for use as testimony in the trial of the action in which offered; or
32 (2) if the judge finds that the declarant is unavailable as a witness at the
33 hearing, testimony given as a witness in another action or in a preliminary
34 hearing or former trial in the same action, or in a deposition taken in
35 compliance with law for use as testimony in the trial of another action,
36 when: (A) The testimony is offered against a party who offered it in the
37 party's own behalf on the former occasion or against the successor in
38 interest of such party; or (B) the issue is such that the adverse party on the
39 former occasion had the right and opportunity for cross-examination with
40 an interest and motive similar to that which the adverse party has in the
41 action in which the testimony is offered, but the provisions of this
42 subsection (c) shall not apply in criminal actions if it denies to the accused
43 the right to meet the witness face to face.

1 (d) *Contemporaneous statements and statements admissible on*
2 *ground of necessity generally.* A statement which the judge finds was
3 made: (1) While the declarant was perceiving the event or condition which
4 the statement narrates, describes or explains; (2) while the declarant was
5 under the stress of a nervous excitement caused by such perception; or (3)
6 if the declarant is unavailable as a witness, by the declarant at a time when
7 the matter had been recently perceived by the declarant and while the
8 declarant's recollection was clear and was made in good faith prior to the
9 commencement of the action and with no incentive to falsify or to distort.

10 (e) *Dying declarations.* A statement by a person unavailable as a
11 witness because of the person's death if the judge finds that it was made:
12 (1) Voluntarily and in good faith; and (2) while the declarant was
13 conscious of the declarant's impending death and believed that there was
14 no hope of recovery.

15 (f) *Confessions.* In a criminal proceeding as against the accused, a
16 previous statement by the accused relative to the offense charged, but only
17 if the judge finds that the accused: (1) When making the statement was
18 conscious and was capable of understanding what the accused said and
19 did; and (2) was not induced to make the statement: (A) Under
20 compulsion or by infliction or threats of infliction of suffering upon the
21 accused or another, or by prolonged interrogation under such
22 circumstances as to render the statement involuntary; or (B) by threats or
23 promises concerning action to be taken by a public official with reference
24 to the crime, likely to cause the accused to make such a statement falsely,
25 and made by a person whom the accused reasonably believed to have the
26 power or authority to execute the same.

27 (g) *Admissions by parties.* As against a party, a statement by the
28 person who is the party to the action in the person's individual or a
29 representative capacity and, if the latter, who was acting in such
30 representative capacity in making the statement.

31 (h) *Authorized and adoptive admissions.* As against a party, a
32 statement: (1) By a person authorized by the party to make a statement or
33 statements for the party concerning the subject of the statement; or (2) of
34 which the party with knowledge of the content thereof has, by words or
35 other conduct, manifested the party's adoption or belief in its truth.

36 (i) *Vicarious admissions.* As against a party, a statement which would
37 be admissible if made by the declarant at the hearing if: (1) The statement
38 concerned a matter within the scope of an agency or employment of the
39 declarant for the party and was made before the termination of such
40 relationship; (2) the party and the declarant were participating in a plan to
41 commit a crime or a civil wrong and the statement was relevant to the plan
42 or its subject matter and was made while the plan was in existence and
43 before its complete execution or other termination; or (3) one of the issues

1 between the party and the proponent of the evidence of the statement is a
2 legal liability of the declarant, and the statement tends to establish that
3 liability.

4 (j) *Declarations against interest.* Subject to the limitations of the
5 exception in subsection (f), a statement which the judge finds was at the
6 time of the assertion so far contrary to the declarant's pecuniary or
7 proprietary interest or so far subjected the declarant to civil or criminal
8 liability or so far rendered invalid a claim by the declarant against another
9 or created such risk of making the declarant an object of hatred, ridicule or
10 social disapproval in the community that a reasonable person in the
11 declarant's position would not have made the statement unless the person
12 believed it to be true.

13 (k) *Voter's statements.* A statement by a voter concerning the voter's
14 qualifications to vote or the fact or content of the voter's vote.

15 (l) *Statements of physical or mental condition of declarant.* Unless
16 the judge finds it was made in bad faith, a statement of the declarant's: (1)
17 Then existing state of mind, emotion or physical sensation, including
18 statements of intent, plan, motive, design, mental feeling, pain and bodily
19 health, but not including memory or belief to prove the fact remembered or
20 believed, when such a mental or physical condition is in issue or is
21 relevant to prove or explain acts or conduct of the declarant; or (2)
22 previous symptoms, pain or physical sensation, made to a physician
23 consulted for treatment or for diagnosis with a view to treatment, and
24 relevant to an issue of declarant's bodily condition.

25 (m) *Business entries and the like.* Writings offered as memoranda or
26 records of acts, conditions or events to prove the facts stated therein, if the
27 judge finds that: (1) They were made in the regular course of a business at
28 or about the time of the act, condition or event recorded; and (2) the
29 sources of information from which made and the method and
30 circumstances of their preparation were such as to indicate their
31 trustworthiness.

32 If the procedure specified by ~~subsection (b)~~ of K.S.A. 60-245a(b), and
33 amendments thereto, for providing business records has been complied
34 with and no party has required the personal attendance of a custodian of
35 the records or the production of the original records, the affidavit or
36 declaration of the custodian shall be prima facie evidence that the records
37 satisfy the requirements of this subsection.

38 (n) *Absence of entry in business records.* Evidence of the absence of a
39 memorandum or record from the memoranda or records of a business of an
40 asserted act, event or condition, to prove the nonoccurrence of the act or
41 event, or the nonexistence of the condition, if the judge finds that it was
42 the regular course of that business to make such memoranda of all such
43 acts, events or conditions at the time thereof or within a reasonable time

1 thereafter and to preserve them.

2 (o) *Content of official record.* Subject to K.S.A. 60-461, and
3 amendments thereto; (1) If meeting the requirements of authentication
4 under K.S.A. 60-465, and amendments thereto, to prove the content of the
5 record, a writing purporting to be a copy of an official record or of an entry
6 therein~~or~~; (2) to prove the absence of a record in a specified office, a
7 writing made by the official custodian of the official records of the office,
8 reciting diligent search and failure to find such record; *or* (3) *to prove the*
9 *absence of a record in the criminal justice information system central*
10 *repository maintained by the Kansas bureau of investigation pursuant to*
11 *K.S.A. 22-4705, and amendments thereto, a writing made by a person*
12 *purporting to be an official custodian of the records of the Kansas bureau*
13 *of investigation, reciting diligent search of criminal history record*
14 *information and electronically stored information, as defined in K.S.A. 22-*
15 *4701, and amendments thereto, and failure to find such record.*

16 (p) *Certificate of marriage.* Subject to K.S.A. 60-461, and
17 amendments thereto, certificates that the maker thereof performed
18 marriage ceremonies, to prove the truth of the recitals thereof, if the judge
19 finds that: (1) The maker of the certificates, at the time and place certified
20 as the times and places of the marriages, was authorized by law to perform
21 marriage ceremonies; and (2) the certificate was issued at that time or
22 within a reasonable time thereafter.

23 (q) *Records of documents affecting an interest in property.* Subject to
24 K.S.A. 60-461, and amendments thereto, the official record of a document
25 purporting to establish or affect an interest in property, to prove the content
26 of the original recorded document and its execution and delivery by each
27 person by whom it purports to have been executed, if the judge finds that:
28 (1) The record is in fact a record of an office of a state or nation or of any
29 governmental subdivision thereof; and (2) an applicable statute authorized
30 such a document to be recorded in that office.

31 (r) *Judgment of previous conviction.* Evidence of a final judgment
32 adjudging a person guilty of a felony, to prove any fact essential to sustain
33 the judgment.

34 (s) *Judgment against persons entitled to indemnity.* To prove the
35 wrong of the adverse party and the amount of damages sustained by the
36 judgment creditor, evidence of a final judgment if offered by a judgment
37 debtor in an action in which the debtor seeks to recover partial or total
38 indemnity or exoneration for money paid or liability incurred by the debtor
39 because of the judgment, provided the judge finds that the judgment was
40 rendered for damages sustained by the judgment creditor as a result of the
41 wrong of the adverse party to the present action.

42 (t) *Judgment determining public interest in land.* To prove any fact
43 which was essential to the judgment, evidence of a final judgment

1 determining the interest or lack of interest of the public or of a state or
2 nation or governmental division thereof in land, if offered by a party in an
3 action in which any such fact or such interest or lack of interest is a
4 material matter.

5 (u) *Statement concerning one's own family history.* A statement of a
6 matter concerning a declarant's own birth, marriage, divorce, legitimacy,
7 relationship by blood or marriage, race-ancestry or other similar fact of the
8 declarant's family history, even though the declarant had no means of
9 acquiring personal knowledge of the matter declared, if the judge finds
10 that the declarant is unavailable.

11 (v) *Statement concerning family history of another.* A statement
12 concerning the birth, marriage, divorce, death, legitimacy, race-ancestry,
13 relationship by blood or marriage or other similar fact of the family history
14 of a person other than the declarant if the judge finds that the declarant: (1)
15 Was related to the other by blood or marriage, or was otherwise so
16 intimately associated with the other's family as to be likely to have
17 accurate information concerning the matter declared, and made the
18 statement as upon information received from the other or from a person
19 related by blood or marriage to the other or as upon repute in the other's
20 family; and (2) is unavailable as a witness.

21 (w) *Statement concerning family history based on statement of*
22 *another declarant.* A statement of a declarant that a statement admissible
23 under the exceptions in subsections (u) or (v) was made by another
24 declarant, offered as tending to prove the truth of the matter declared by
25 both declarants, if the judge finds that both declarants are unavailable as
26 witnesses.

27 (x) *Reputation in family concerning family history.* Evidence of
28 reputation among members of a family, if the reputation concerns the birth,
29 marriage, divorce, death, legitimacy, race-ancestry or other fact of the
30 family history of a member of the family by blood or marriage.

31 (y) *Reputation—boundaries, general history, family history.* Evidence
32 of reputation in a community as tending to prove the truth of the matter
33 reputed, if the reputation concerns: (1) Boundaries of or customs affecting,
34 land in the community and the judge finds that the reputation, if any, arose
35 before controversy;; (2) an event of general history of the community or of
36 the state or nation of which the community is a part and the judge finds
37 that the event was of importance to the community; or (3) the birth,
38 marriage, divorce, death, legitimacy, relationship by blood or marriage, or
39 race-ancestry of a person resident in the community at the time of the
40 reputation, or some other similar fact of the person's family history or of
41 the person's personal status or condition which the judge finds likely to
42 have been the subject of a reliable reputation in that community.

43 (z) *Reputation as to character.* If a trait of a person's character at a

1 specified time is material, evidence of the person's reputation with
2 reference thereto at a relevant time in the community in which the person
3 then resided or in a group with which the person then habitually
4 associated, to prove the truth of the matter reputed.

5 (aa) *Recitals in documents affecting property.* Evidence of a statement
6 relevant to a material matter, contained in a deed of conveyance or a will
7 or other document purporting to affect an interest in property, offered as
8 tending to prove the truth of the matter stated, if the judge finds that: (1)
9 The matter stated would be relevant upon an issue as to an interest in the
10 property; and (2) the dealings with the property since the statement was
11 made have not been inconsistent with the truth of the statement.

12 (bb) *Commercial lists and the like.* Evidence of statements of matters
13 of interest to persons engaged in an occupation contained in a list, register,
14 periodical or other published compilation, to prove the truth of any
15 relevant matter so stated, if the judge finds that the compilation is
16 published for use by persons engaged in that occupation and is generally
17 used and relied upon by them.

18 (cc) *Learned treatises.* A published treatise, periodical or pamphlet on
19 a subject of history, science or art, to prove the truth of a matter stated
20 therein, if the judge takes judicial notice, or a witness expert in the subject
21 testifies, that the treatise, periodical or pamphlet is a reliable authority in
22 the subject.

23 (dd) *Actions involving children.* In a criminal proceeding or a
24 proceeding pursuant to the revised Kansas juvenile justice code or in a
25 proceeding to determine if a child is a child in need of care under the
26 revised Kansas code for care of children, a statement made by a child, to
27 prove the crime or that a child is a juvenile offender or a child in need of
28 care, if:

29 (1) The child is alleged to be a victim of the crime or offense or a
30 child in need of care; and

31 (2) the trial judge finds, after a hearing on the matter, that the child is
32 disqualified or unavailable as a witness, the statement is apparently
33 reliable and the child was not induced to make the statement falsely by use
34 of threats or promises.

35 If a statement is admitted pursuant to this subsection in a trial to a jury,
36 the trial judge shall instruct the jury that it is for the jury to determine the
37 weight and credit to be given the statement and that, in making the
38 determination, it shall consider the age and maturity of the child, the
39 nature of the statement, the circumstances under which the statement was
40 made, any possible threats or promises that might have been made to the
41 child to obtain the statement and any other relevant factor.

42 (ee) *Certified motor vehicle certificate of title history.* Subject to
43 K.S.A. 60-461, and amendments thereto, a certified motor vehicle

1 certificate of title history prepared by the division of vehicles of the
2 Kansas department of revenue.

3 Sec. 4. K.S.A. 60-465 is hereby amended to read as follows: 60-465.
4 A writing purporting to be a copy of an official record or of an entry
5 therein, meets the requirements of authentication if the judge finds that the
6 writing purports to be published by authority of the nation, state or
7 subdivision thereof, in which the record is kept or evidence has been
8 introduced sufficient to warrant a finding that the writing is a correct copy
9 of the record or entry. Extrinsic evidence of authenticity as a condition
10 precedent to admissibility is not required if: (1) The office in which the
11 record is kept is within this state and the writing is attested as a correct
12 copy of the record or entry by a person purporting to be an officer, or a
13 deputy of an officer, having the legal custody of the record; (2) *the office*
14 *in which the record is kept is within this state and the record is attested by*
15 *a person purporting to be an official custodian of the records of the*
16 *Kansas bureau of investigation as a correct copy of criminal history*
17 *record information or electronically stored information, as defined in*
18 *K.S.A. 22-4701, and amendments thereto, accessed through the criminal*
19 *justice information system central repository maintained by the Kansas*
20 *bureau of investigation pursuant to K.S.A. 22-4705, and amendments*
21 *thereto;* (3) the office in which the record is kept is within the United
22 States or territory or insular possession subject to the dominion of the
23 United States and the writing is attested to as required in ~~clause~~ *paragraph*
24 (1) and authenticated by seal of the office having custody or, if that office
25 has no seal, by a public officer having a seal and having official duties in
26 the district or political subdivision in which the records are kept who
27 certifies under seal that such officer has custody; or ~~(3)~~ (4) the office in
28 which the record is kept is in a foreign state or country, the writing is
29 attested as required in ~~clause~~ *paragraph* (1) and is accompanied by a
30 certificate that such officer has the custody of the record which certificate
31 may be made by a secretary of an embassy or legation, consul general,
32 consul, vice-consul, or consular agent or by any officer in the foreign
33 service of the United States stationed in the foreign state or country in
34 which the record is kept, and authenticated by the seal of that office.

35 Sec. 5. K.S.A. 60-465 and K.S.A. 2015 Supp. 22-4701, 22-4705 and
36 60-460 are hereby repealed.

37 Sec. 6. This act shall take effect and be in force from and after its
38 publication in the statute book.
