1 AN ACT concerning the state board of healing arts; relating to ~~the~~ *powers,*
2 *duties and functions;* licensure of acupuncturists; *regulation of*
3 *physical therapists; physical therapy scope of practice;* amending
4 K.S.A. 2015 Supp. 65-2872, *65-2901 and 65-2913* and repealing the
5 existing ~~section~~ *sections.*

7 *Be it enacted by the Legislature of the State of Kansas:*

8 ~~New Section 1. Sections 1 through 24, and amendments thereto, shall~~
9 ~~be known and may be cited as the acupuncturist and oriental medicine~~
10 ~~practice act.~~

11 ~~New Sec. 2. As used in sections 1 through 24, and amendments~~
12 ~~thereto:~~

13 (a) ~~"Act" means the acupuncturist and oriental medicine practice act.~~

14 (b) ~~"Acupuncture" means a distinct system of health care, based on~~
15 ~~traditional and modern oriental medical concepts, to examine, evaluate,~~
16 ~~diagnose, manage or treat disease, illness, injury, pain or other physical or~~
17 ~~mental conditions in order to promote the restoration and maintenance of~~
18 ~~health and wellness.~~

19 (c) ~~"Licensed acupuncturists" means any person licensed by the board~~
20 ~~in the practice of acupuncturist and oriental medicine.~~

21 (d) ~~"Auricular detox technician" means a person trained solely in, and~~
22 ~~who performs only, auricular detox treatment.~~

23 (e) ~~"Auricular detox treatment" means a very limited procedure~~
24 ~~consisting of acupuncturist needles inserted into specified points in the~~
25 ~~outer ear of a person undergoing treatment for drug or alcohol abuse or~~
26 ~~both drug and alcohol abuse.~~

27 (f) ~~"Board" means the state board of healing arts.—~~

28 (g) ~~"Council" means the acupuncturist advisory council.~~

29 (h) ~~"Oriental medicine" means Chinese medicine, traditional Chinese~~
30 ~~medicine, Asian medicine, East Asian medicine and the other names used~~

1 to describe such medical model and the therapies taught within such
2 medical model.

3 (i) ~~"NCCAOM" means the national certification commission for~~
4 ~~acupuncture and oriental medicine. NCCAOM is a national organization~~
5 ~~that validates entry-level competency in the practice of acupuncture and~~
6 ~~oriental medicine through the administration of professional certification~~
7 ~~examinations.~~

8 (j) ~~"Physician" means a person licensed to practice medicine and~~
9 ~~surgery in Kansas.~~

10 (k) ~~"Practice of acupuncture and oriental medicine" means the use,~~
11 ~~recommendation and application of oriental medicine therapies, within the~~
12 ~~scope of and based on oriental medicine concepts.~~

13 (1) ~~Oriental medicine therapies include, but are not limited to:~~

14 (A) ~~Acupuncture treatment and those related techniques which~~
15 ~~involve the insertion and removal of needles through the skin at specific~~
16 ~~points on the body with or without the palpation of specific points on the~~
17 ~~body, with or without manipulation of the needles and with or without the~~
18 ~~application of heat sources or electrical current. This includes, but is not~~
19 ~~limited to, the techniques sometimes called "dry needling," "trigger point~~
20 ~~therapy," "intramuscular therapy," "auricular detox treatment" and similar~~
21 ~~terms;~~

22 (B) ~~mechanical, thermal, pressure, suction, friction, electrical,~~
23 ~~magnetic, light, sound, vibration, manual treatment and electromagnetic~~
24 ~~treatment;~~

25 (C) ~~the use, application or recommendation of therapeutic exercises,~~
26 ~~breathing techniques, meditation and dietary and nutritional counseling~~
27 ~~based on oriental medicine principles; and~~

28 (D) ~~the use and recommendation of herbal products and nutritional~~
29 ~~supplements, according to the acupuncturist's level of training and~~
30 ~~certification as a diplomate in oriental medicine or diplomate in herbology~~
31 ~~by NCCAOM.~~

32 (2) ~~Oriental medicine therapies do not include:~~

33 (A) ~~Dispensing or administering of any controlled substances as~~
34 ~~defined in K.S.A. 65-4101, and amendments thereto, or any prescription-~~
35 ~~only drugs;~~

36 (B) ~~medicine and surgery including the use of lasers for surgical~~
37 ~~purposes as practiced by physicians and surgeons;~~

38 (C) ~~osteopathic medicine and surgery or osteopathic manipulative~~
39 ~~treatment; or~~

40 (D) ~~the practice of chiropractic as defined by article 28 of chapter 65~~
41 ~~of the Kansas Statutes Annotated, and amendments thereto.~~

42 ~~New Sec. 3. (a) On and after July 1, 2017, except as otherwise~~
43 ~~provided in this act, no person shall practice acupuncture unless such~~

1 person possesses a current and valid acupuncture license issued under this
2 act, is licensed to practice medicine and surgery, is a licensed chiropractor
3 or is a licensed naturopathic doctor.

4 (b) (1) ~~No person shall depict oneself orally or in writing, expressly~~
5 ~~or by implication, as a holder of a Kansas acupuncture license who does~~
6 ~~not hold a current and valid acupuncture and oriental medicine license~~
7 ~~under this act.~~

8 (2) ~~Only a person licensed as an acupuncturist under the acupuncture~~
9 ~~and oriental medicine practice act shall be entitled to use the following~~
10 ~~titles, as appropriate: "Licensed acupuncturist," "oriental medicine~~
11 ~~practitioner," "practitioner of oriental medicine," abbreviations thereof or~~
12 ~~words similar to such titles or the designated letters "L.Ac."~~

13 (3) ~~Nothing in this section shall be construed to prohibit an~~
14 ~~acupuncturist licensed under this act from listing or using in conjunction~~
15 ~~with their name any letters, words, abbreviations or other insignia to~~
16 ~~designate any educational degrees, certifications or credentials which such~~
17 ~~licensed acupuncturist has earned. Each licensee, when using the letters or~~
18 ~~term "Dr." or "Doctor" in conjunction with such licensee's professional~~
19 ~~practice, whether in any written or oral communication, shall identify~~
20 ~~oneself as a doctor of oriental medicine.~~

21 (4) ~~Only a person licensed as an acupuncturist under this act shall be~~
22 ~~entitled, as appropriate, to represent oneself, in any manner, as specializing~~
23 ~~in or practicing any form of oriental medicine in the state of Kansas.~~

24 (e) ~~Needles used in the practice of acupuncture shall only be~~
25 ~~prepackaged, single use and sterile needles. These needles shall only be~~
26 ~~used on an individual patient in a single treatment session.~~

27 New Sec. 4. (a) ~~The following shall be exempt from the requirement~~
28 ~~of an acupuncture license pursuant to this act:~~

29 (1) ~~A person licensed to practice medicine and surgery, a licensed~~
30 ~~chiropractor or a licensed naturopathic doctor if the person confines the~~
31 ~~person's acts or practice to the scope of practice authorized by the other~~
32 ~~health professional licensing laws and does not represent to the public,~~
33 ~~directly or indirectly, that under this act:~~

34 (A) ~~The person is licensed under this act; or~~

35 (B) ~~through the usage of a name, title or other designation, the person~~
36 ~~indicates licensure;~~

37 (2) ~~any herbalist or herbal retailer who does not hold oneself out to be~~
38 ~~a licensed acupuncturist;~~

39 (3) ~~health care providers in the United States armed forces, federal~~
40 ~~facilities and other military service when acting in the line of duty in this~~
41 ~~state;~~

42 (4) ~~any student, trainee or visiting teacher of acupuncture, oriental~~
43 ~~medicine or herbology who is designated as a student, trainee or visiting~~

1 teacher while participating in a course of study or training under the
2 supervision of a licensed acupuncturist licensed under this act in a program
3 that the council has approved. This includes continuing education
4 programs and any acupuncture, oriental medicine or herbology programs
5 that are a recognized route by the NCCAOM to certification in
6 acupuncture, oriental medicine or herbology;

7 (5) persons rendering assistance in the case of an emergency or
8 disaster relief;

9 (6) self-care by a patient or gratuitous care by a family member who
10 does not represent or hold oneself out to the public to be a licensed
11 acupuncturist;

12 (7) persons who massage, so long as such persons do not practice
13 acupuncture and oriental medicine or hold themselves out to be licensed
14 acupuncturists or oriental medicine practitioners;

15 (8) any team acupuncturist, oriental medicine or herbology
16 practitioner, who is traveling with and treating those associated with an
17 out-of-state or national team that is temporarily in the state for training or
18 competition purposes; and

19 (9) any person who is an auricular detox technician, provided that
20 such person performs only auricular detox treatments under the
21 supervision of a licensed acupuncturist.

22 (b) This section shall take effect on and after July 1, 2017.

23 New Sec. 5. (a) An applicant for licensure as an acupuncturist shall
24 file an application, on forms provided by the board, showing to the
25 satisfaction of the board that the applicant meets the following
26 requirements:

27 (1) At the time of application such applicant is at least 21 years of
28 age;

29 (2) has graduated from a school or an apprenticeship program
30 recognized by the NCCAOM, or its equivalent, and approved by the board
31 and satisfies one of the following requirements:

32 (A) Has the active status of a NCCAOM certified diplomate of
33 acupuncture;

34 (B) has the active status of a NCCAOM certified diplomate of
35 oriental medicine; or

36 (C) has an equivalent status as recognized by the council and
37 approved by the board;

38 (3) demonstrates the ability to communicate in the English language
39 as determined by rules and regulations adopted by the board if English is a
40 second language for the applicant;

41 (4) has good moral character; and

42 (5) has paid all the fees required for licensure prescribed in section 8,
43 and amendments thereto, which shall be nonrefundable.

1 ~~(b) Notwithstanding subsection (a), the board may issue a license to a~~
2 ~~person who has been in the active practice of acupuncture or oriental~~
3 ~~medicine in some other state, territory, the District of Columbia or other~~
4 ~~country upon certificate of the proper licensing authority of that state,~~
5 ~~territory, District of Columbia or other country certifying that the applicant~~
6 ~~is duly licensed, certified or registered, that the applicant's license,~~
7 ~~certification or registration has never been limited, suspended or revoked,~~
8 ~~that the licensee, certification or registration holder has never been~~
9 ~~censured or had other disciplinary action taken and that, so far as the~~
10 ~~records of such authority are concerned, the applicant is entitled to its~~
11 ~~endorsement. The applicant shall also present proof satisfactory to the~~
12 ~~board:~~

13 ~~(1) (A) That the state, territory, District of Columbia or country in~~
14 ~~which the applicant last practiced maintains standards at least equal to~~
15 ~~those maintained by Kansas;~~

16 ~~(B) that the applicant's original license, certification or registration~~
17 ~~was based upon licensure, certification or registration requirements at least~~
18 ~~equal in quality to the state of Kansas licensure requirements pursuant to~~
19 ~~this section;~~

20 ~~(C) of the date of the applicant's original and any and all endorsed~~
21 ~~licenses, certifications or registrations and the date and place from which~~
22 ~~any license, certification or registration was attained; and~~

23 ~~(D) that the applicant has been actively engaged in acupuncture and~~
24 ~~oriental medicine under such license, certification or registration since~~
25 ~~issued, and if not, indicate the time when and reason why the applicant~~
26 ~~was out of practice.~~

27 ~~An applicant for license by endorsement shall not be granted a license~~
28 ~~unless such applicant's individual qualifications meet the state of Kansas~~
29 ~~requirements;~~

30 ~~(2) the applicant shall demonstrate the ability to communicate in the~~
31 ~~English language, if English is a second language for such applicant, as~~
32 ~~determined by rules and regulations adopted by the board; and~~

33 ~~(3) the applicant shall pay all fees required for licensure as prescribed~~
34 ~~by section 8, and amendments thereto, which shall be nonrefundable.~~

35 ~~(e) The board may issue a license to a person who does not meet the~~
36 ~~qualifications listed in subsection (a), but who has practiced acupuncture~~
37 ~~and oriental medicine in Kansas during three of the last five years~~
38 ~~preceding the effective date of this act. Such applicant shall meet the~~
39 ~~following requirements:~~

40 ~~(1) The applicant shall provide proof of a minimum of 1,350 hours of~~
41 ~~study, excluding online study, in the field of acupuncture obtained on or~~
42 ~~before July 1, 2017;~~

43 ~~(2) the applicant's practice shall include a minimum of 1,500 patient~~

1 visits to the applicant for the purpose of acupuncture and oriental medicine
2 services for three of the last five years preceding application for licensure.
3 Documentation shall include:

4 (A) Two affidavits from office partners, clinic supervisors,
5 accountants or other individuals approved by the board, who have personal
6 knowledge of the years of practice and number of patients visiting the
7 applicant for acupuncture and oriental medicine services; and

8 (B) notarized copies of appointment books, patient charts, financial
9 records or other documentation as required by the board, except that no
10 personally identifiable patient health information in violation of or
11 protected by the provisions of the health insurance portability and
12 accountability act of 1996 shall be disclosed;

13 (3) the applicant must show that any complaints against the applicant
14 have been absolved or resolved to the satisfaction of the board;

15 (4) the applicant's application for licensure shall be submitted on or
16 before January 1, 2018;

17 (5) the applicant shall demonstrate the ability to communicate in the
18 English language, if English is a second language for such applicant, as
19 determined by rules and regulations adopted by the board; and

20 (6) the applicant shall pay all fees required for licensure as prescribed
21 by section 8, and amendments thereto, which shall be nonrefundable.

22 (d) Notwithstanding subsections (a) and (c), the board may issue a
23 license to a person who successfully passes the NCCAOM board
24 examinations and who submits an application for license under the act on
25 or before January 1, 2018.

26 (e) A person whose license has been revoked may make written
27 application to the board requesting reinstatement of the license in a manner
28 prescribed by the board. An application for reinstatement of a license shall
29 be accompanied by the fee provided for in section 8, and amendments
30 thereto, and as established in the rules and regulations adopted by the
31 board.

32 New Sec. 6.—(a) There is hereby created the designation of inactive
33 license. The board is authorized to issue an inactive license to any licensee
34 who makes written application for such license on a form provided by the
35 board and remits the fee for an inactive license established pursuant to
36 section 8, and amendments thereto.

37 (b) The board may issue an inactive license only to a person who
38 meets all the requirements for a license to practice as an acupuncturist and
39 who does not engage in the active practice of acupuncture and oriental
40 medicine in the state of Kansas.

41 (c) An inactive license shall not entitle the holder to engage in active
42 practice. The provisions of section 7, and amendments thereto, relating to
43 expiration, renewal and reinstatement of a license shall be applicable to an

1 inactive license issued under this subsection. Each inactive licensee may
2 apply to engage in active practice by presenting a request required by
3 section 5, and amendments thereto. The request shall be accompanied by
4 the fee established pursuant to section 8, and amendments thereto.

5 (d) ~~This section shall take effect on and after July 1, 2017.~~

6 ~~New Sec. 7. (a) Licenses issued annually under this act shall be~~
7 ~~canceled on March 31 of each year unless renewed in the manner~~
8 ~~prescribed by the board. A license issued or reinstated from January 1~~
9 ~~through March 31 shall be cancelled on March 31 of the following year. A~~
10 ~~request for the renewal of a license shall be on a form provided by the~~
11 ~~board and shall be accompanied by the renewal fee established pursuant to~~
12 ~~section 8, and amendments thereto, which shall be paid not later than the~~
13 ~~renewal date of the license.~~

14 (b) ~~At least 60 days before the renewal date of a licensee's license, the~~
15 ~~board shall notify the licensee of the licensure renewal date by mail~~
16 ~~addressed to the licensee's last mailing address as noted upon the office~~
17 ~~records. If the licensee fails to submit an application for renewal of~~
18 ~~licensure on a form provided by the board, or fails to pay the renewal fee~~
19 ~~by the date of cancellation, the board shall give notice to the licensee that~~
20 ~~the license has been canceled and the license may be renewed only if an~~
21 ~~application for active status reinstatement, a renewal fee, and a late~~
22 ~~renewal fee are received by the board. If cancelled for at least one year but~~
23 ~~not more than five years, an active status license shall be reinstated when~~
24 ~~an appropriate fee has been paid and proof of NCCAOM current~~
25 ~~credentials has been presented, or an equivalent status as recognized by the~~
26 ~~council and approved by the board in lieu of the NCCAOM credentials.~~

27 (c) ~~The board may require any licensee to submit to a continuing~~
28 ~~education audit and provide to the board evidence of satisfactory~~
29 ~~completion of a program of continuing education required by rules and~~
30 ~~regulations of the board. The board may accept a licensee's current active~~
31 ~~status as a NCCAOM diplomate of acupuncture or NCCAOM diplomate~~
32 ~~of oriental medicine as proof of satisfactory completion of continuing~~
33 ~~education requirements.~~

34 (d) ~~The board, prior to renewal of a license, shall require the licensee,~~
35 ~~if in the active practice of acupuncture and oriental medicine within the~~
36 ~~state, to submit to the board evidence satisfactory to the board that the~~
37 ~~licensee is maintaining a policy of professional liability insurance. The~~
38 ~~board may require any licensee to provide to the board evidence of~~
39 ~~malpractice insurance.~~

40 (e) ~~This section shall take effect on and after July 1, 2017.~~

41 ~~New Sec. 8. (a) The board shall charge and collect in advance fees for~~
42 ~~acupuncturists, as follows, through March 31, 2018:-~~

15 (b) After March 31, 2018, the board shall charge and collect in
 16 advance fees for acupuncturists as established by the board by rules and
 17 regulations not to exceed the amounts in subsection (a).

18 (c) If an examination is not administered by the board, the board may
 19 require that fees paid for any examination under the acupuncture and
 20 oriental medicine practice act be paid directly to the examination service
 21 by the person taking the examination.

22 New Sec. 9. The board shall remit all moneys received by or for the
 23 board from fees, charges or penalties to the state treasurer in accordance
 24 with the provisions of K.S.A. 75-4215, and amendments thereto. Upon
 25 receipt of each such remittance, the state treasurer shall deposit the entire
 26 amount in the state treasury. Twenty percent of such amount shall be
 27 credited to the state general fund and the balance shall be credited to the
 28 healing arts fee fund. All expenditures from the healing arts fee fund shall
 29 be made in accordance with appropriation acts upon warrants of the
 30 director of accounts and reports issued pursuant to vouchers approved by
 31 the president of the board or by a person or persons designated by the
 32 president.

33 New Sec. 10. (a) There is established the acupuncture advisory
 34 council to assist the state board of healing arts in carrying out the
 35 provisions of this act. The council shall consist of five members, all
 36 citizens and residents of the state of Kansas, appointed as follows:

37 (1) The board, with recommendation from the Kansas association of
 38 oriental medicine, shall appoint:

39 (A) Two members who are actively licensed as acupuncturists under
 40 this act; and

41 (B) one member who is actively licensed as an acupuncturist under
 42 this act and holds a current NCCAOM certification in herbology or
 43 oriental medicine;

1 ~~(2) one member shall be the president of the state board of healing~~
2 ~~arts or a person designated by the president; and—~~

3 ~~(3) the governor shall appoint one member from the public sector~~
4 ~~who is not engaged, directly or indirectly, in the provision of health~~
5 ~~services. Insofar as possible, persons appointed to the council shall be~~
6 ~~from different geographic areas. If a vacancy occurs on the council, the~~
7 ~~appointing authority of the position which has become vacant shall appoint~~
8 ~~a person of like qualifications to fill the vacant position for the unexpired~~
9 ~~term, if any.~~

10 ~~(b) The member of the council appointed by the governor shall be~~
11 ~~appointed for a term of three years and until a successor is appointed. The~~
12 ~~members appointed by the state board of healing arts shall serve at the~~
13 ~~pleasure of the state board of healing arts. If a member is designated by the~~
14 ~~president of the state board of healing arts, the member shall serve at the~~
15 ~~pleasure of the president.~~

16 ~~(c) Acupuncturists initially appointed to the council must be eligible,~~
17 ~~as appropriate, for licensure pursuant to section 5, and amendments~~
18 ~~thereto. On and after July 1, 2017, new appointees, as appropriate, shall be~~
19 ~~licensed under the provisions of this act.~~

20 ~~(d) The council shall meet at least once each year at a time and place~~
21 ~~of its choosing and at such other times as may be necessary on the~~
22 ~~chairperson's call or on the request of a majority of the council's members.~~
23 ~~At the first meeting, the council shall select a chairperson and vice-~~
24 ~~chairperson, and annually thereafter. The first meeting shall be called by~~
25 ~~the president of the state board of healing arts or such person's designee.~~

26 ~~(e) A majority of the council constitutes a quorum. No action may be~~
27 ~~taken by the council except by affirmative vote of the majority of the~~
28 ~~members present and voting.~~

29 ~~(f) Members of the council attending meetings of the council, or~~
30 ~~attending a subcommittee meeting thereof authorized by the council, shall~~
31 ~~be paid amounts provided in K.S.A. 75-3223(e), and amendments thereto,~~

33 ~~New Sec. 11. The acupuncturist advisory council shall advise the~~
34 ~~board regarding:~~

35 ~~(a) Examination, licensing and other fees;~~

36 ~~(b) rules and regulations to be adopted to carry out the provisions of~~
37 ~~this act;~~

38 ~~(c) the number of yearly continuing education hours required to~~
39 ~~maintain active licensure;~~

40 ~~(d) changes and new requirements taking place in the areas of~~
41 ~~acupuncture and oriental medicine; and~~

42 ~~(e) such other duties and responsibilities as the board may assign.~~

43 ~~New Sec. 12. The board, with the advice and assistance of the~~

1 acupuncture advisory council, shall:

2 (a) ~~Duly license and regulate applicants for licensure and keep a~~
3 ~~roster of all such licensed individuals;~~

4 (b) ~~adopt rules and regulations as may be necessary to administer the~~
5 ~~provisions of this act and prescribe forms which shall be issued in the~~
6 ~~administration of this act;~~

7 (c) ~~establish standards for approval of an educational course of study~~
8 ~~and clinical experience;~~

9 (d) ~~establish criteria for continuing education;~~

10 (e) ~~establish standards of professional conduct, procedure for the~~
11 ~~discipline of licensees and keep a record of all such proceedings; and~~

12 (f) ~~establish standards for clean needle technique.~~

13 New Sec. 13. (a) ~~A licensee's license may be revoked, suspended or~~
14 ~~limited, or the licensee may be publicly or privately censured, or an~~
15 ~~application for a license or for reinstatement of a license may be denied~~
16 ~~upon a finding of the existence of any of the following grounds:~~

17 (1) ~~The licensee has committed an act of unprofessional conduct as~~
18 ~~defined by rules and regulations adopted by the board;~~

19 (2) ~~the licensee has obtained a license by means of fraud,~~
20 ~~misrepresentations or concealment of material facts;~~

21 (3) ~~the licensee has committed an act of professional incompetency as~~
22 ~~defined by rules and regulations adopted by the board;~~

23 (4) ~~the licensee has been convicted of a felony;~~

24 (5) ~~the licensee has violated any provision of this act;~~

25 (6) ~~the licensee has violated any lawful order or rule and regulation of~~
26 ~~the board;~~

27 (7) ~~the licensee has been found to be mentally ill, disabled, not guilty~~
28 ~~by reason of insanity, not guilty because the licensee suffers from a mental~~
29 ~~disease or defect or incompetent to stand trial by a court of competent~~
30 ~~jurisdiction;~~

31 (8) ~~the licensee has failed to report to the board any adverse action~~
32 ~~taken against the licensee by another state or licensing jurisdiction, a peer~~
33 ~~review body, a health care facility, a professional association or society, a~~
34 ~~governmental agency, a law enforcement agency or a court for acts or~~
35 ~~conduct similar to acts or conduct which would constitute grounds for~~
36 ~~disciplinary action under this section;~~

37 (9) ~~the licensee has surrendered a license or authorization to practice~~

6 *or society while under investigation for acts or conduct similar to acts or*
7 *conduct which would constitute grounds for disciplinary action under*

9 *(11) the licensee has an adverse judgment, award or settlement*
10 *against the licensee resulting from a medical liability claim related to*
11 *acts or conduct similar to acts or conduct which would constitute*
12 *grounds for disciplinary action under this section;*

13 *(12) the licensee has failed to report to the board any adverse*
14 *judgment, settlement or award against the licensee resulting from a*
15 *medical malpractice liability claim related to acts or conduct similar to*
16 *acts or conduct which would constitute grounds for disciplinary action*
17 *under this section; or*

18 *(13) the licensee's ability to practice with reasonable skill and safety*
19 *to patients is impaired by reason of physical or mental illness, or*
