1 AN ACT concerning crimes, punishment and criminal procedure; relating
2 to expungement; arrest records; amending K.S.A. 2015 Supp. 22-2410
3 and repealing the existing section.
4

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2015 Supp. 22-2410 is hereby amended to read as
7 follows: 22-2410. (a) (1) Any person who has been arrested in this state
8 may petition the district court for the expungement of such arrest record.

9 (2) *If a person has been arrested in this state as a result of mistaken*
10 *identity or as a result of another person using the identifying information*
11 *of the named person, and the charge against the named person is*
12 *dismissed or not prosecuted, the prosecuting attorney or other judicial*
13 *officer who ordered the dismissal or declined to prosecute shall provide*
14 *notice to the court of such action and petition the district court for the*
15 *expungement of such arrest record, and the court shall order the arrest*
16 *record and subsequent court proceedings, if any, expunged. For purposes*
17 *of this section, the term "mistaken identity" means the erroneous arrest of*
18 *a person for a crime as a result of misidentification by a witness or law*
19 *enforcement, confusion on the part of a witness or law enforcement as to*
20 *the identity of the person who committed the crime, misinformation*
21 *provided to law enforcement as to the identity of the person who*
22 *committed the crime or some other mistake on the part of a witness or law*
23 *enforcement as to the identity of the person who committed the crime.*

24 (b) (1) When a petition for expungement is filed pursuant to
25 subsection (a)(1), the court shall set a date for hearing on such petition and
26 shall cause notice of such hearing to be given to the prosecuting attorney
27 and the arresting law enforcement agency. *Any person who may have*
28 *relevant information about the petitioner may testify at the hearing. The*
29 *court may inquire into the background of the petitioner.*

30 (2) When a petition for expungement is filed pursuant to subsection
31 (a)(1) or (a)(2), the official court file shall be separated from the other
32 records of the court, and shall be disclosed only to a judge of the court and
33 members of the staff of the court designated by a judge of the district
34 court, the prosecuting attorney, the arresting law enforcement agency, or
35 any other person when authorized by a court order, subject to any
36 conditions imposed by the order.

1 (3) (A) Except as otherwise provided by law, a petition for
2 expungement *pursuant to subsection (a)(1)* shall be accompanied by a
3 docket fee in the amount of \$176. Except as provided further, the docket
4 fee established in this section shall be the only fee collected or moneys in
5 the nature of a fee collected for the docket fee. Such fee shall only be
6 established by an act of the legislature and no other authority is established
7 by law or otherwise to collect a fee. On and after July 1, 2015, through
8 June 30, 2017, the supreme court may impose an additional charge, not to
9 exceed \$19 per docket fee, to fund the costs of non-judicial personnel. ~~The~~
10 ~~petition shall state:~~

11 ~~(1) The petitioner's full name;~~

12 ~~(2) the full name of the petitioner at the time of arrest, if different~~
13 ~~than the petitioner's current name;~~

14 ~~(3) the petitioner's sex, race and date of birth;~~

15 ~~(4) the crime for which the petitioner was arrested;~~

16 ~~(5) the date of the petitioner's arrest; and~~

17 ~~(6) the identity of the arresting law enforcement agency.~~

18 (B) No surcharge or fee shall be imposed to any person filing a
19 petition pursuant to ~~this section~~ *subsection (a)(1)*, who was arrested as a
20 result of being a victim of identity theft under K.S.A. 21-4018, prior to its
21 repeal, or K.S.A. 2015 Supp. 21-6107(a), and amendments thereto, or who
22 has had criminal charges dismissed because a court has found that there
23 was no probable cause for the arrest, the petitioner was found not guilty in
24 court proceedings or the charges have been dismissed. ~~Any person who~~
25 ~~may have relevant information about the petitioner may testify at the~~
26 ~~hearing. The court may inquire into the background of the petitioner.~~

27 (4) *The petition filed pursuant to subsection (a)(1) or (a)(2) shall*
28 *state:*

29 (A) *The petitioner's full name;*

30 (B) *the full name of the petitioner at the time of arrest, if different*
31 *than the petitioner's current name;*

32 (C) *the petitioner's sex, race and date of birth;*

33 (D) *the crime for which the petitioner was arrested;*

34 (E) *the date of the petitioner's arrest; and*

35 (F) *the identity of the arresting law enforcement agency.*

36 (c) At the hearing on a petition for expungement *pursuant to*
37 *subsection (a)(1)*, the court shall order the arrest record and subsequent
38 court proceedings, if any, expunged upon finding:

39 (1) The arrest occurred because of mistaken identity;

40 (2) a court has found that there was no probable cause for the arrest;

41 (3) the petitioner was found not guilty in court proceedings; or

42 (4) the expungement would be in the best interests of justice and: (A)
43 Charges have been dismissed; or (B) no charges have been or are likely to

1 be filed.

2 (d) When the court has ordered expungement of an arrest record and
3 subsequent court proceedings, if any, the order shall state the information
4 required to be stated in the petition and shall state the grounds for
5 expungement under subsection (a)(2) or (c). The clerk of the court shall
6 send a certified copy of the order to the Kansas bureau of investigation
7 which shall notify the federal bureau of investigation, the secretary of
8 corrections and any other criminal justice agency which may have a record
9 of the arrest. If an order of expungement is entered, the petitioner *pursuant*
10 *to subsection (a)(1) or the person eligible for mandatory expungement*
11 *pursuant to subsection (a)(2)* shall be treated as not having been arrested.

12 (e) If the ground for expungement is as provided in subsection (c)(4),
13 the court shall determine whether, in the interests of public welfare, the
14 records should be available for any of the following purposes:

15 (1) In any application for employment as a detective with a private
16 detective agency, as defined in K.S.A. 75-7b01, and amendments thereto;
17 as security personnel with a private patrol operator, as defined by K.S.A.
18 75-7b01, and amendments thereto; or with an institution, as defined in
19 K.S.A. 76-12a01, and amendments thereto, of the Kansas department for
20 aging and disability services;

21 (2) in any application for admission, or for an order of reinstatement,
22 to the practice of law in this state;

23 (3) to aid in determining the petitioner's qualifications for
24 employment with the Kansas lottery or for work in sensitive areas within
25 the Kansas lottery as deemed appropriate by the executive director of the
26 Kansas lottery;

27 (4) to aid in determining the petitioner's qualifications for executive
28 director of the Kansas racing commission, for employment with the
29 commission or for work in sensitive areas in parimutuel racing as deemed
30 appropriate by the executive director of the commission, or to aid in
31 determining qualifications for licensure or renewal of licensure by the
32 commission;

33 (5) in any application for a commercial driver's license under K.S.A.
34 8-2,125 through 8-2,142, and amendments thereto;

35 (6) to aid in determining the petitioner's qualifications to be an
36 employee of the state gaming agency;

37 (7) to aid in determining the petitioner's qualifications to be an
38 employee of a tribal gaming commission or to hold a license issued
39 pursuant to a tribal-state gaming compact; or

40 (8) in any other circumstances which the court deems appropriate.

41 (f) The court shall make all expunged records and related information
42 in such court's possession, created prior to, on and after July 1, 2011,
43 available to the Kansas bureau of investigation for the purposes of:

1 (1) Completing a person's criminal history record information within
2 the central repository in accordance with K.S.A. 22-4701 et seq., and
3 amendments thereto; or

4 (2) providing information or documentation to the federal bureau of
5 investigation, in connection with the national instant criminal background
6 check system, to determine a person's qualification to possess a firearm.

7 (g) Subject to any disclosures required under subsection (e), in any
8 application for employment, license or other civil right or privilege, or any
9 appearance as a witness, a person whose arrest records have been
10 expunged as provided in this section may state that such person has never
11 been arrested.

12 (h) Whenever a ~~petitioner's~~ *person's* arrest records have been
13 expunged as provided in this section, the custodian of the records of arrest,
14 incarceration due to arrest or court proceedings related to the arrest, shall
15 not disclose the arrest or any information related to the arrest, except as
16 directed by the order of expungement or when requested by the person
17 whose arrest record was expunged.

18 (i) The docket fee collected at the time the petition for expungement
19 is filed *pursuant to subsection (a)(1)* shall be disbursed in accordance with
20 K.S.A. 20-362, and amendments thereto.

21 Sec. 2. K.S.A. 2015 Supp. 22-2410 is hereby repealed.
