SUPPLEMENTAL NOTE ON HOUSE BILL NO. 2213

As Amended by House Committee on Elections

Brief*

HB 2213 addresses contribution limits and regulation thereof. The bill would increase the aggregate amount that could be contributed to a candidate and the candidate's committee by any political committee or any person except a party committee, the candidate, or the candidate's spouse, as follows:

The bill also would increase the aggregate amount that could be contributed to a party committee* as follows:

Party Committee Contribution Limits, for Each Calendar Year	Current Law		HB 2213	
To a state party committee by a person other than a national party committee or political committee.	\$	15,000	\$	30,000
To any other party committee by a person other than a national party committee or a political committee.	\$	5,000	\$	10,000

Finally, the bill would allow a candidate to receive, but not spend, contributions for a general election during the primary election period. If a candidate does not run for a general election for which contributions have been received during the primary election period, the candidate would be required to return the money to the contributor.

Background

The bill was introduced by the House Committee on Elections. Testimony was provided to the House Elections Committee by three proponents: the Chairperson of the Kansas Democratic Party; the Executive Director of the Kansas Republican Party; and the Sedgwick County Clerk. Neutral testimony was received from the Executive Director of the Kansas Governmental Ethics Commission (KGEC), who explained the current contribution limits have been in place since 1990 except that State Board of Education candidate contribution limits were raised in 2012 from \$500 to \$1,000.

The House Committee amended the bill to increase the contribution limit for county officers in large districts, double the limits on contributions to party committees, and prohibit general election contributions collected during a primary election period from being spent during the primary election period.

The fiscal note provided by the Division of the Budget indicates the bill as introduced would have no fiscal effect.
