### Monday, January 11th

First day of 2016 session; convene at 2:00 p.m.

#### Monday, February 1st

Last day for <u>member</u> or <u>members</u> to submit <u>REQUESTS</u> to Revisor's office for bill drafts.

### Monday, February 8th

Last day for <u>Committees</u>, except House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized, to submit <u>REQUESTS</u> to Revisor's office for bill drafts

#### Wednesday, February 10th

Last day for <u>Individuals</u> to <u>INTRODUCE</u> bills in originating chamber.

### Friday, February 12th

Last day for <u>Committees</u>, except committees listed above, to <u>INTRODUCE</u> bills in originating chamber.

## Friday, February 26th (Turnaround Day)

Last day to <u>CONSIDER BILLS IN HOUSE OF ORIGIN</u>, except by House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized.

### Wednesday, March 23rd

Last day to <u>CONSIDER BILLS NOT IN HOUSE OF ORIGIN</u>, except by committees listed above.

#### Friday, April 1st (Drop Dead Day)

No bills considered after this date except <u>BILLS VETOED BY</u> <u>GOVERNOR</u>, <u>OMNIBUS APPROPRIATIONS ACT AND</u> <u>OMNIBUS RECONCILIATIONS SPENDING LIMIT BILL</u>.

Veto session is anticipated to begin on Wednesday, <u>April 27<sup>th</sup></u>, Sine Die-to be announced.
