Proponent Testimony on **HB 2411** (2017) & **HB 2470** (2018)

Chairman Barker, and Members of the Committee,

I am Philip Bradley representing the Craft Brewers Guild of Kansas. Thank you for the opportunity to present testimony today.

There are currently 45 Microbrewery and Package Warehouse Facility Licenses in Kansas. There is a list attached to this testimony.


These figures show the growth that creates challenges for any industry but it is the kind of challenge that is fantastic for the State of Kansas. I believe we all want that growth to continue. It translates into jobs, investment, purchases, taxes and a better economy. And it is not exclusive to metro areas. You can see growth all over the state. We ask for your action allowing this industry to help itself in Kansas.

**HB 2470** is the current language and should supersede **HB 2411**. We believe these adjustments will only enhance the business climate of Kansas and **are of no harm to the state or its citizens**. **HB 2470** addresses one significant issue; *the ability to grow*. This is not a random request. This practice used in many states. Also, this measure is designed to work within current systems and utilizes the tiered structure.

We ask that pg. 2, line 17 be amended to clarify the intent; transfer back to the original contracting brewer.

We ask you to **pass favorably HB 2470** and if appropriate recommend it for the Consent agenda.
