I am a graduate of North High, and have attended Wichita State University.

I am also a Deferred Action for Early Childhood Arrivals (or DACA) recipient and the daughter of undocumented parents.

My family moved here when I was 3 years old.

Since then, they have raised me as a Kansan and I consider this my home.

My parents have worked hard to give me a better life. They have risked everything so that I can have a shot at the American dream, and I have and will continue in doing my part to make the most of this opportunity.

I have attended Wichita State University as full time student. Being a first generation college student in my family was a blessing and full of opportunities.

But I recognize that the opportunities I have today, are the result of hard fought struggles lead by immigrants.

HB2643 is a bill to support the funding of post secondary tuition fees for Kansas Foster Child Educational Act.

I completely support a post secondary education for Foster children but this bill has a twist to it ending instate tuition for undocumented students. This is putting two marginalized groups against each other, which is wrong in all ways!

Since 2004 undocumented students who have attended more than 3 years in Kansas High School AND have graduated from a Kansas High School can continue their education by being allowed to pay instate tuition.

This allows for about 600 students in Kansas to continue and become nurses, doctors, teachers, etc... and contribute to the state we grew up in.

Many believe that undocumented students receive federal aid and I am here to assure you that is completely untrue.

Students that are undocumented are not allowed to receive any federal aid and to prove that I have my receipts here of payments that are from me working hard and paying out of pocket to work towards a bachelors degree.

If a repeal to instate tuition is passed, roughly 600+ students will not be able to afford to out of state tuition of pocket and continue their education. This is revenue that the universities are making!

I urge you to not support the repeal of instate for 600+ undocumented students in the state of Kansas.
