Dear Representative Huebert, Education Chairman,

I am deeply concerned and request that the legislators limit the ability of the KDHE to mandate more vaccines. I do not feel it is the right of the Government and Pharmaceutical companies to mandate what I need for my health. I stand for Health Care Freedom to allow individuals to research and decide for themselves what goes into their bodies.

I am an RN, BSN and have over 30 years of nursing experience in health care. I was forced out of my nursing career, as it became mandatory to continue my position that I have a yearly flu vaccine. I feel it should be my right to decide, if I need a flu shot or not, without loss of my job. The CDC best practices state that frequent thorough handwashing and cleaning surfaces is one of the best prevention measures. The flu vaccine strain given for a particular year, is not necessarily the strain that will be most active that year. I am a 61 y/o healthy female and have no major health issues and have never had the flu. I feel it is my right not to be injected with a vaccine that is produced from aborted fetal DNA, aluminum, formaldehyde or thimerosal/ mercury. I was taught years ago in nursing school not to touch a broken mercury thermometer, as mercury can attack the nervous system. Why would I want this injected into my body?
