

Re: HB 2601

My name is Kara Sears and my son suffered from vaccines. As an infant he literally screamed non-stop for SIX DAYS STRAIGHT following a routine round of shots. I called his doctor a handful of times that week only to be told that this was “normal” and to “just give him Tylenol.”

After the MMR at 13 months and the Hep A at 15 months, he lost all of his words and he didn't call me "Momma" again for over a year. I documented everything which made it easy to look back and put the pieces together. He wasn't the same kid and I know when he changed. He forgot milestones he had previously mastered, such as: climbing stairs, playing with his toys and eating. He became clumsy. Suddenly he was running into things and falling down. He would flip light switches for hours and line up all of his toy cars, all facing the same direction in perfect rows; even sorted by color. He wasn't even two years old. He was labeled as “borderline autistic” but he was never diagnosed so he never qualified for services. No one told me what I needed to do to heal my baby. No one told me how I had to completely change his diet. No one told me what supplements to give him. No one told me how to get the toxins out of his tiny baby body. No one helped me pay for any of it. No one helped me with his speech therapy for 3-4 hours every single day. No one saw our progress and patted us on the back. No one held me while I sat curled up crying in the shower night after night. No one told me that vaccines could possibly hurt my child. I had to find all of that out on my own. I had to make time to do real research. No one could be held accountable besides ME, when all I did was what our doctor told me I HAD to do to keep my baby safe. We are still paying the price, six years later.

Please take a little time to do some real research. Read the package inserts. The manufacturers themselves admit the harm that their product may cause yet they are free from any and all liability. It makes no sense. Follow the money trails. I don't have to tell you who the most powerful lobbyists are in Washington. There will come a time when the truth can no longer be bought.

Nobody is doing the safety studies. There is no proof that the benefits of vaccines do not outweigh the risks because those studies have never been done. The CDC does not claim to have done them, which is a direct violation to the 1986 National Childhood Vaccine Injury Act. There is ZERO liability when vaccines cause harm because Congress protects vaccine manufacturers by granting them economic immunity - yet at the same time under the same law, congress also requires HHS to oversee vaccine studies, and testing, and provide biennial reports on safety to make or insure improvements in, and to reduce the risk of adverse reactions to vaccines. A recent lawsuit revealed that out of the 64 reports for these safety studies required by CONGRESS, a total of **ZERO** have been done. Not one single safety study has been done in over 30 years and the health of an entire nation suffers. Robert F. Kennedy, Jr. says “As a nation, we can no longer pretend our trusted agencies are protecting our children. It is time to hold federal agencies accountable.” And I agree. These agencies should not be allowed to police themselves.
