Chairman Huebert and members of the Committee:

Thank you for the opportunity to be here today opposing HB2601 on behalf of the Kansas Academy of Family Physicians (KAFP). My name is Chad Johanning and I am a practicing family physician in Lawrence and President-Elect of KAFP.

It is important that the list of school vaccination requirements remain in the current KDHE administrative regulations and not codified in Kansas statutes. Nor do we believe immunization requirements should expire, once adopted, and cause an undue burden on KDHE, making them repeat the regulation process year after year. HB 2601 risks Kansas' ability to respond to the best scientific recommendations for immunizations, as set forth by the Advisory Committee on Immunization Practices (ACIP) to protect our children from vaccine-preventable diseases. It also undermines KDHE's mission, which is *to protect and improve the health and environment of all Kansans*.

Each quarter, ACIP reviews all available science before deciding on vaccine recommendations. ACIP recommendations inform decisions to both add *and* remove vaccines from the list of Kansas requirements. **We oppose this bill and are in favor of the Kansas Department of Health and Environment Secretary retaining the flexibility and authority to be responsive to new vaccines recommended by the ACIP as part of the routine child and adolescent vaccination schedule. The current process offers the best protection for Kansas children and adolescents.**

The current administrative process allows a *timely, evidence-based* response to changes in ACIP recommendations, both to add *and* remove vaccines from the requirements list. Listing vaccines in statute, as in HB 2601, would create a needlessly cumbersome process for change, even with the provisions offered.

It is worthy to note nearly every state delegates the authority to determine vaccination requirements to their respective state health department. In Kansas, minimal changes have been made to the list of school vaccination requirements, only three times in the past 41 years. The current regulation process is used only as necessary to align Kansas childcare and school requirements with the best evidence-based, scientific recommendations available.

Vaccines are safe and given to millions of children each year. Side effects are generally minor and temporary; serious reactions are very rare. The United States vaccine safety program closely and constantly monitors the safety of vaccines. Vaccinations have significantly decreased rates of vaccine-preventable diseases and are the single most impactful achievement in public health.

Thank you for the opportunity to present our concern. We **oppose HB 2601** and are in favor of the Kansas Department of Health and Environment Secretary retaining the flexibility and authority to be responsive to new vaccines recommended by the ACIP as part of the routine child and adolescent vaccination schedule. Thank you again for this opportunity to testify on behalf of KAFP. I am happy to stand for any questions you may have, at the appropriate time.
