RE HB 2601

Dear Education Committee Members,

We are writing regarding the HB2601 and the authority of KDHE to add mandatory vaccinations to the school schedule.

We have a child who was injured by vaccines, receiving 6 at once. She has several health problems we believe are related to vaccinations, and after much research, we discontinued vaccinating any of our children. Because we no longer followed the CDC recommended schedule of 72 doses by age 18, our Pediatrician kicked us out their practice that we had been going to regularly for 5 years. Blue Cross and Blue Shield gives bonuses to Pediatricians for having a certain percentage of vaccination rates, and they lose the bonus if they fall below the required percentage. This made us feel that they are motivated by money and not actual care of their patients. This greatly upset our children. They were asking "Doesn't the doctor care about us? We didn't do anything. We matter too, we need a doctor too, why are the vaccinated kids more important than us?" They felt betrayed, and less than worthy. They felt like the Doctor should be looking out for their best interests, and they felt abandoned. They now have an innate distrust of Pediatricians and their motives. My 11 year old is now passionate about fighting for rights and freedom of choice. This has caused them emotional trauma. It has been difficult to find another Pediatrician. Prior to us finding a new Pediatrician, I twice needed a referral to a Specialist and the prior office refused to get one from a new Pediatrician.

Pediatricians advise to introduce new foods to your baby one at a time with 3 days in between, and then will inject babies with 8 different viruses including all the toxins and adjuvants at one time, that have never been tested for safety.

There has never been a safety study done on giving multiple vaccines at once. There has never been a double blind placebo safety study done on combining multiple vaccines in one dose. There has never been a safety study done on even a single dose of any vaccine against a double blind placebo, they have only been tested against another vaccine, not a placebo.

Where there is risk, there must be choice. It is not that I am against vaccinations, it is that I am against forced, government controlled and mandated vaccinations with no choice in what is being injected into our children, where there are known risks and side effects, and there is no liability against the manufacturers. All the vaccine drug manufacturers have been convicted of fraud, and falsifying data, every single one.

Schools today are seeing an explosion of chronically ill children. 54% of US children have a chronic illness. Cancer is the #1 cause of death by disease among children under the age of 15 in the United States. Aborted fetal cells are used in several of the vaccines. Fetal stem cells have never been able to be used in treatments because they replicate into cancerous cells.

We are injecting babies with large amounts of highly toxic substances to keep the healthy?! Injection bypasses our bodies natural defense systems that happen when the same substances are ingested.
