Testimony to the House Financial Institutions and Pensions Committee In Support of HB2031 February 6, 2019

Chairman Kelly and Committee Members,

Our associations support HB2031. Police Officers, Firefighters and Emergency Medical personnel are often exposed to hazardous substances that can lead to disabling diseases. The primary exposure for law enforcement officers is exposure to diseases through either blood or saliva. These exposures for law enforcement often happen at times when it is impossible to use protective gear, for example, taking a resistive suspect into custody who is either bleeding from injuries or spits on officers.

This bill establishes an officer who is a KP&F member and disabled by certain diseases will qualify for KP&F disability. The bill appears to have adequate provisions to assure the conditions are duty related and that employees are cooperating with preventative treatment and testing after exposure.

Our proposed amendments will cover contagious diseases included in the bill were determined by the Kansas Department of Health and Environment pursuant to KSA 65-128. The 2013 Legislature directed KDHE to develop regulations "... providing for the protection of individuals who provide medical or nursing services, clinical or forensic laboratory services, emergency medical services and firefighting, law enforcement and correctional services... where the individual may encounter occupational exposure to blood and other potentially infectious materials." It seems only to use this list of diseases established as those diseases we typically encounter.

The exposure risk to law enforcement officers to carcinogens also occurs, although probably not at the risk level of our firefighters. Therefore, we also support the provisions regarding the cancers proposed in the bill.

We ask for your support of HB2031.

HOUSE BILL No. 2031

AN ACT concerning retirement and pensions; relating to the Kansas police and firemen's retirement system; definition of service-connected; amending K.S.A. 74-4952 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 74-4952 is hereby amended to read as follows: 74-4952. As used in K.S.A. 74-4951 et seq., and amendments thereto:

(1) "Accumulated contributions" means the sum of all contributions by a member to the system which shall be credited to the member's account with interest allowed thereon after June 30, 1982.

(2) "Disability" means the total inability to perform permanently the duties of the position of a policeman or fireman.

(3) "Eligible employer" means any city, county, township or other political subdivision of the state employing one or more employees as firemen or policemen.

(4) "Employee" means any policeman or fireman employed by a participating employer whose employment for police or fireman purposes is not seasonal or temporary and requires at least 1,000 hours of work per year.

(5) "Entry date" means the date as of which an eligible employer joins the system; the first entry date pursuant to this act is January 1, 1967.

(6) "Final average salary" means:

(a) For members who are first hired as an employee, as defined in subsection (4), before July 1, 1993, the average highest annual compensation paid to a member for any three of the last five years of participating service immediately preceding retirement or termination of employment, or if participating service is less than three years, then the average annual compensation paid to the member during the full period of participating service, or if a member has less than one calendar year of participating service, then the member's final average salary shall be computed by multiplying the member's highest monthly salary received in that year by 12;

(b) for members who are first hired as an employee, as defined in subsection (4), on and after July 1, 1993, the average highest annual salary, as defined in K.S.A. 74-4902(33), and amendments thereto, paid to a member for any three of the last five years of participating service
