1 AN ACT regulating traffic; concerning negligent driving, penalty; 2 amending K.S.A. 2018 Supp. 8-2118 and repealing the existing section.

4 Be it enacted by the Legislature of the State of Kansas:

5 New Section 1. (a) No person shall operate or halt any vehicle in such 6 a manner as to indicate a careless or heedless disregard for the right or the 7 safety of others, or inattentively in such a manner as to endanger, or be 8 likely to endanger, any person or property.

9 (b) This section shall be a part of and supplemental to the uniform act 10 regulating traffic on highways.

Sec. 2. K.S.A. 2018 Supp. 8-2118 is hereby amended to read as follows: 8-2118. (a) A person charged with a traffic infraction shall, except as provided in subsection (b), appear at the place and time specified in the notice to appear. If the person enters an appearance, waives right to trial, pleads guilty or no contest, the fine shall be no greater than that specified in the uniform fine schedule in subsection (c) and court costs shall be taxed as provided by law.

18 (b) Prior to the time specified in the notice to appear, a person 19 charged with a traffic infraction may enter a written appearance, waive 20 right to trial, plead guilty or no contest and pay the fine for the violation as 21 specified in the uniform fine schedule in subsection (c) and court costs 22 provided by law. Payment may be made in any manner accepted by the 23 court. The traffic citation shall not have been complied with if the payment 24 is not honored for any reason, or if the fine and court costs are not paid in full. When a person charged with a traffic infraction makes payment 25 26 without executing a written waiver of right to trial and plea of guilty or no 27 contest, the payment shall be deemed such an appearance, waiver of right 28 to trial and plea of no contest.

(c) The following uniform fine schedule shall apply uniformly throughout the state but shall not limit the fine-which *that* may be imposed following a court appearance, except an appearance made for the purpose of pleading and payment as permitted by subsection (a). The description of offense contained in the following uniform fine schedule is for reference only and is not a legal definition.

2 (d) Traffic offenses classified as traffic infractions by this section 3 shall be classified as ordinance traffic infractions by those cities adopting 4 ordinances prohibiting the same offenses. A schedule of fines for all 5 ordinance traffic infractions shall be established by the municipal judge in the manner prescribed by K.S.A. 12-4305, and amendments thereto. Such 6 7 fines may vary from those contained in the uniform fine schedule 8 contained in subsection (c).

9 (e) Fines listed in the uniform fine schedule contained in subsection 10 (c) shall be doubled if a person is convicted of a traffic infraction, which is defined as a moving violation in accordance with rules and regulations 11 12 adopted pursuant to K.S.A. 8-249, and amendments thereto, committed 13 within any road construction zone as defined in K.S.A. 8-1458a, and 14 amendments thereto

15 (f) For a second violation of K.S.A. 8-1908 or 8-1909, and 16 amendments thereto, within two years after a prior conviction of K.S.A. 8-17 1908 or 8-1909, and amendments thereto, such person, upon conviction 18 shall be fined 11/2 times the applicable amount from one, but not both, of 19 the schedules listed in the uniform fine schedule contained in subsection 20 (c). For a third violation of K.S.A. 8-1908 or 8-1909, and amendments 21 thereto, within two years, after two prior convictions of K.S.A. 8-1908 or 22 8-1909, and amendments thereto, such person, upon conviction shall be 23 fined two times the applicable amount from one, but not both, of the 24 schedules listed in the uniform fine schedule contained in subsection (c). 25 For a fourth and each succeeding violation of K.S.A. 8-1908 or 8-1909, 26 and amendments thereto, within two years after three prior convictions of 27 K.S.A. 8-1908 or 8-1909, and amendments thereto, such person, upon 28 conviction shall be fined $2\frac{1}{2}$ times the applicable amount from one, but not 29 both, of the schedules listed in the uniform fine schedule contained in 30 subsection (c).

31 Fines listed in the uniform fine schedule contained in subsection (g) 32 (c) relating to exceeding the maximum speed limit, shall be doubled if a 33 person is convicted of exceeding the maximum speed limit in a school 34 zone authorized under K.S.A. 8-1560(a)(4), and amendments thereto.

35 (h) For a second violation of K.S.A. 8-1556, and amendments thereto, 36 within five years after a prior conviction of K.S.A. 8-1556, and 37 amendments thereto, such person, upon conviction, shall be fined \$750 for 38 the second violation. For a third and each succeeding violation of K.S.A. 39 8-1556, and amendments thereto, within five years after two prior 40 convictions of K.S.A. 8-1556, and amendments thereto, such person, upon 41 conviction, shall be fined \$1,000 for the third and each succeeding violation 42 43

Sec. 3. K.S.A. 2018 Supp. 8-2118 is hereby repealed.
