AN ACT concerning crimes, punishment and criminal procedure; relating 1 2 to definitions in the Kansas criminal code; possession; amending 3 K.S.A. 2019 Supp. 21-5111 and repealing the existing section. 4 5 Be it enacted by the Legislature of the State of Kansas: 6 Section 1. K.S.A. 2019 Supp. 21-5111 is hereby amended to read as 7 follows: 21-5111. The following definitions shall apply when the words 8 and phrases defined are used in this code, except when a particular context 9 clearly requires a different meaning. "Act" includes a failure or omission to take action. 10 (a) 11 "Another" means a person or persons as defined in this code other (b) 12 than the person whose act is claimed to be criminal. 13 "Conduct" means an act or a series of acts, and the accompanying (c) 14 mental state. 15 (d) "Conviction" includes a judgment of guilt entered upon a plea of 16 guilty. 17 "Deception" means knowingly creating or reinforcing a false (e) impression, including false impressions as to law, value, intention or other 18 19 state of mind. Deception as to a person's intention to perform a promise 20 shall not be inferred from the fact alone that such person did not subsequently perform the promise. Falsity as to matters having no 21 22 pecuniary significance, or puffing by statements unlikely to deceive 23 reasonable persons, is not deception. 24 "Deprive permanently" means to: (f) 25 (1) Take from the owner the possession, use or benefit of property. 26 without an intent to restore the same: 27 (2) retain property without intent to restore the same or with intent to 28 restore it to the owner only if the owner purchases or leases it back, or 29 pays a reward or other compensation for its return; or 30 (3) sell, give, pledge or otherwise dispose of any interest in property 31 or subject it to the claim of a person other than the owner. 32 "Distribute" means the actual or constructive transfer from one (g) 33 person to another of some item whether or not there is an agency 34 relationship. "Distribute" includes, but is not limited to, sale, offer for sale, 35 furnishing, buying for, delivering, giving, or any act that causes or is 36 intended to cause some item to be transferred from one person to another.

"Distribute" does not include acts of administering, dispensing or
 prescribing a controlled substance as authorized by the pharmacy act of the
 state of Kansas, the uniform controlled substances act, or otherwise
 authorized by law.

(h) "DNA" means deoxyribonucleic acid.

6 "Domestic violence" means an act or threatened act of violence (i) 7 against a person with whom the offender is involved or has been involved 8 in a dating relationship, or an act or threatened act of violence against a 9 family or household member by a family or household member. Domestic 10 violence also includes any other crime committed against a person or against property, or any municipal ordinance violation against a person or 11 against property, when directed against a person with whom the offender is 12 involved or has been involved in a dating relationship or when directed 13 14 against a family or household member by a family or household member. 15 For the purposes of this definition:

16 (1) "Dating relationship" means a social relationship of a romantic 17 nature. In addition to any other factors the court deems relevant, the trier 18 of fact may consider the following when making a determination of 19 whether a relationship exists or existed: Nature of the relationship, length 20 of time the relationship existed, frequency of interaction between the 21 parties and time since termination of the relationship, if applicable.

22 (2) "Family or household member" means persons 18 years of age or 23 older who are spouses, former spouses, parents or stepparents and children 24 or stepchildren, and persons who are presently residing together or have 25 resided together in the past, and persons who have a child in common regardless of whether they have been married or have lived together at any 26 27 time. Family or household member also includes a man and woman if the 28 woman is pregnant and the man is alleged to be the father, regardless of 29 whether they have been married or have lived together at any time.

(j) "Domestic violence offense" means any crime committed wherebythe underlying factual basis includes an act of domestic violence.

(k) "Dwelling" means a building or portion thereof, a tent, a vehicle
or other enclosed space which is used or intended for use as a human
habitation, home or residence.

(1) "Expungement" means the sealing of records such that the records
are unavailable except to the petitioner and criminal justice agencies as
provided by K.S.A. 22-4701 et seq., and amendments thereto, and except
as provided in this act.

(m) "Firearm" means any weapon designed or having the capacity topropel a projectile by force of an explosion or combustion.

(n) "Forcible felony" includes any treason, murder, voluntary
manslaughter, rape, robbery, burglary, arson, kidnapping, aggravated
battery, aggravated sodomy and any other felony which involves the use or

1 threat of physical force or violence against any person.

2 (o) "Intent to defraud" means an intention to deceive another person, and to induce such other person, in reliance upon such deception, to 3 assume, create, transfer, alter or terminate a right, obligation or power with 4 5 reference to property.

(p) "Law enforcement officer" means:

7 (1) Any person who by virtue of such person's office or public 8 employment is vested by law with a duty to maintain public order or to 9 make arrests for crimes, whether that duty extends to all crimes or is 10 limited to specific crimes;

(2) any officer of the Kansas department of corrections or, for the 11 purposes of K.S.A. 2019 Supp. 21-5412 and subsection (d) of K.S.A. 2019 12 Supp. 21-5413(d), and amendments thereto, any employee of the Kansas 13 department of corrections; or 14

(3) any university police officer or campus police officer, as defined 15 16 in K.S.A. 22-2401a, and amendments thereto.

(q) "Obtain" means to bring about a transfer of interest in or 17 possession of property, whether to the offender or to another. 18

"Obtains or exerts control" over property includes, but is not 19 (r) 20 limited to, the taking, carrying away, sale, conveyance, transfer of title to, 21 interest in, or possession of property. 22

"Owner" means a person who has any interest in property. (s)

23 (t) "Person" means an individual, public or private corporation, government, partnership, or unincorporated association. 24

25 (u) "Personal property" means goods, chattels, effects, evidences of rights in action and all written instruments by which any pecuniary 26 obligation, or any right or title to property real or personal, shall be 27 28 created, acknowledged, assigned, transferred, increased, defeated, 29 discharged, or dismissed.

(v) "Possession" means *knowingly* having joint or exclusive control 30 over an item-with knowledge of or intent to have such control or 31 32 knowingly keeping some item in-a any place where the person has some 33 measure of access and right of control.

34 (w) "Property" means anything of value, tangible or intangible, real 35 or personal.

36 "Prosecution" means all legal proceedings by which a person's (x) 37 liability for a crime is determined.

38 (y) "Prosecutor" means the same as prosecuting attorney in K.S.A. 39 22-2202, and amendments thereto.

"Public employee" is a person employed by or acting for the state 40 (z) 41 or by or for a county, municipality or other subdivision or governmental instrumentality of the state for the purpose of exercising their respective 42 43 powers and performing their respective duties, and who is not a "public 1 officer."

2 (aa) "Public officer" includes the following, whether elected or 3 appointed:

4 (1) An executive or administrative officer of the state, or a county, 5 municipality or other subdivision or governmental instrumentality of or 6 within the state;

7 (2) a member of the legislature or of a governing board of a county,
8 municipality; or other subdivision of or within the state;

9 (3) a judicial officer, which shall include a judge of the district court, 10 juror, master or any other person appointed by a judge or court to hear or 11 determine a cause or controversy;

(4) a hearing officer, which shall include any person authorized by
law or private agreement, to hear or determine a cause or controversy and
who is not a judicial officer;

(5) a law enforcement officer; and

(6) any other person exercising the functions of a public officer undercolor of right.

(bb) "Real property" or "real estate" means every estate, interest, andright in lands, tenements and hereditaments.

20 (cc) "Solicit" or "solicitation" means to command, authorize, urge, 21 incite, request or advise another to commit a crime.

(dd) "State" or "this state" means the state of Kansas and all land and
water in respect to which the state of Kansas has either exclusive or
concurrent jurisdiction, and the air space above such land and water.
"Other state" means any state or territory of the United States, the District
of Columbia and the Commonwealth of Puerto Rico.

(ee) "Stolen property" means property over which control has beenobtained by theft.

(ff) "Threat" means a communicated intent to inflict physical or otherharm on any person or on property.

(gg) "Written instrument" means any paper, document or other instrument containing written or printed matter or the equivalent thereof, used for purposes of reciting, embodying, conveying or recording information, and any money, token, stamp, seal, badge, trademark, or other evidence or symbol of value, right, privilege or identification, which that is capable of being used to the advantage or disadvantage of some person.
