## HOUSE BILL No. 2408



1 AN ACT concerning the disposition of certain state real property;  
2 authorizing the state historical society to convey certain real property  
3 located in Doniphan county; imposing certain conditions; prescribing  
4 costs of conveyance.  
5

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. (a) Subject to the provisions of this section, the state  
8 historical society, for and on behalf of the state of Kansas, is hereby  
9 authorized to convey, ~~without consideration,~~ to the Iowa Tribe of Kansas  
10 and Nebraska all of the rights, title and interest in the following described  
11 real estate, and any improvements thereon, located in Doniphan county,  
12 Kansas, containing 9.86 acres more or less:

13 A tract of land beginning at a point on the east line of section 24,  
14 Township 2 south, Range 19 east of the 6<sup>th</sup> Principal Meridian 570 feet  
15 north of the center of the slab on U.S. highway No. 36, thence north on the  
16 section line 848.5 feet; thence west 334 feet; thence north 45 degrees and  
17 25 minutes west 233 feet; thence north 87 degrees and 19 minutes west  
18 145.5 feet; thence south 26 degrees and 10 minutes west 377.5 feet; thence  
19 south 52 degrees and 41 minutes east 242 feet; thence south 48 degrees  
20 and 10 minutes east 818 feet to point of beginning; all in the East half of  
21 the East half of said Section 24.

22 (b) Conveyance of such rights, title and interest in such real estate,  
23 and any improvements thereon, shall be executed in the name of the state  
24 historical society by the executive director of the state historical society by  
25 ~~statutory warranty deed~~  without the necessity of appraisal, bid or  
26 publication and shall not be subject to the provisions of K.S.A. 75-3043a,  
27 and amendments thereto. No exchange and conveyance of real estate, and  
28 any improvements thereon, as authorized by this section shall be made by  
29 the executive director until the deeds and conveyances have been reviewed  
30 and approved by the attorney general.

31 (c) The property to be conveyed is listed in the national register of  
32 historic places as "Iowa, Sac and Fox Presbyterian Mission." The Iowa  
33 Tribe of Kansas and Nebraska agrees to pay all costs related to the  
34 conveyance and shall grant the state a historic preservation easement that  
35 will reflect current federal preservation laws regarding properties listed in  
36 the national register of historic places.
