Thank you, Mr. Chairman and members of the committee for entertaining this cannabis bill. The way cannabis has been used as a political weapon by all levels and branches of government is tragic. I further believe the blame for complications during state sovereign policy changes regarding the status of cannabis as a state-controlled substance rests squarely on the shoulders of the Federal government as it pertains to the original repugnant classification of cannabis as a schedule 1 controlled substance and the continued pseudo-prohibition that presents itself in the form of this qualitative and quantitated bill
