Re: Prison Bed Impact Assessment - **SB 7 - Extending terminal medical release to inmates in the custody of the department of corrections with a condition likely to cause death within 120 days.**

IMPACT ASSESSMENT

- **Impact on Prison Admissions:** This bill will have **no** impact on prison admissions.
- **Impact on Prison Beds:** This bill **may** have an impact on prison beds, but cannot be determined at this time.
- **Impact on the Commission Workload:** This bill would result in **no** additional workload of the Commission.

SUMMARY OF THE BILL

This bill amends K.S.A. 2020 Supp. 22-3729 to increase the time the Prisoner Review Board may grant release to an inmate that has a terminal medical condition likely to cause death within 120 days rather than the current 30 days.

FINDINGS

- According to KDOC data, on June 30, 2019, there were **305** (3%) inmates who were age 61 or older. Of these offenders,
 - **83.9%** (256) were between the ages of 61 and 70 years old.
 - **15.4%** (47) were between the ages of 71 and 80 years old.
 - **0.7%** (2) were 81 years old and above.

- According to KDOC's evaluation, based upon a review of medical cases of residents currently incarcerated, KDOC estimates that 9-10 people per year would be eligible for

consideration for terminal medical release if the period was extended to 120 days. Based on the current 30-day period, in fiscal years 2016 through 2020, either 0 or 1 applications were submitted per year.
