AN ACT concerning elections; relating to election audits; concerning 1 2 election procedures; amending K.S.A. 25-3009 and repealing the 3 existing section. 4 5 Be it enacted by the Legislature of the State of Kansas: 6 New Section 1. (a) In the calendar year following the general 7 election of an even-numbered year, the secretary of state shall conduct in four counties an audit of the procedures used for election administration 8 9 and election records for the elections held during the previous two 10 calendar years. 11 (b) The secretary of state shall select the counties to be audited at 12 random, except that: 13 (1) One of the counties selected shall have a voting age population of 14 more than 90,000; 15 (2) one of the counties selected shall have a voting age population of 16 more than 20,000 but less than 90,000; (3) two of the counties selected shall have a voting age population of 17 18 less than 20,000; 19 (4) a county selected in the three most recent audit cycles shall not be 20 selected in the current audit cycle; and 21 (5) voting age population shall be set by the most recent federal 22 decennial census. 23 (c) The secretary of state shall adopt rules and regulations necessary to implement this section including enumerating the specific records and 24 25 procedures to be examined. 26 Sec. 2. K.S.A. 25-3009 is hereby amended to read as follows: 25-27 3009. (a) After an election and prior to the meeting of the county board of 28 canvassers to certify the official election results for any election in which 29 the canvassers certify the results, the county election officer shall conduct 30 a manual audit or tally of each vote cast, regardless of the method of 31 voting, in 1% of all precincts, with a minimum of one precinct located 32 within the county. The precinct or precincts shall be randomly selected and 33 the selection shall take place after the election. 34 (b) (1) The audit shall be performed manually and shall review all 35 paper ballots selected pursuant to subsection (a). The audit shall be performed by a sworn election board consisting of bipartisan trained board 36

- members. The county election officer-will shall determine the members of 1 2 the sworn election board who will conduct the audit.

 - (2)The audit-will shall review contested races as follows:
- (A) In presidential election years: 4
- 5 (i) One federal race;
 - (ii) one state legislative race; and
 - (iii) one county race.
- 8 (B) In-even numbered even-numbered, non-presidential election 9 years:
 - (i) One federal race;
 - (ii) one statewide race;
- (iii) one state legislative race; and 12
- 13 (iv) one county race.

(C) In even-numbered election years, any federal, statewide or state 14 legislative race that is within 1% of the total number of votes cast tallied 15 16 on election night, as determined by the secretary of state, shall be audited. 17 The county election officer shall conduct the audit in the manner set forth 18 in subsection (a) in 10% of all county precincts in the specified race, with 19 a minimum of one precinct in the county. The precincts audited pursuant 20 to this subsection shall be in addition to the precincts audited under 21 subsections (2)(A) and (B).

22 (D) In odd-numbered election years, two local races will be randomly 23 selected, and the selection shall take place after the election.

24 (c) At least five days prior to the audit, notice of the time and location 25 of the audit shall be provided to the public on the official county website. The audit shall be conducted in a public setting. Any candidate or entity 26 27 who is authorized to appoint a poll agent may appoint a poll agent for the 28 audit.

29 (d) The results of the audit shall be compared to the unofficial 30 election night returns and a report shall be submitted to the county election 31 office and to the secretary of state's office prior to the meeting of the 32 county board of canvassers. If a discrepancy is reported between the audit 33 and the unofficial returns and cannot be resolved, the county election 34 officer or the secretary of state may require audits of additional precincts. 35 Once the audit has been completed, the results of the audit shall be used by 36 the county board of canvassers when certifying the official election results.

37 (e) The secretary of state shall adopt rules and regulations governing 38 the conduct and procedure of the audit, including the random selection of 39 the precincts and offices involved in the audit.

(f) The provisions of this section shall apply to all counties for-40 41 elections that take place after January 1, 2019.
