1	AN ACT concerning the Kansas offender registration act; requiring
2 3	registration for violations of internet trading in child pornography and aggravated internet trading in child pornography; amending K.S.A.
4	2021 Supp. 22-4902 and 22-4906 and repealing the existing sections.
5	2021 Supp. 22 1902 and 22 1900 and repeating the emoting sections.
6	Be it enacted by the Legislature of the State of Kansas:
7	Section 1. K.S.A. 2021 Supp. 22-4902 is hereby amended to read as
8	follows: 22-4902. As used in the Kansas offender registration act, unless
9	the context otherwise requires:
10	(a) "Offender" means:
11	(1) A sex offender;
12	(2) a violent offender;
13	(3) a drug offender;
14	(4) any person who has been required to register under out-of-state
15	law or is otherwise required to be registered; and
16	(5) any person required by court order to register for an offense not
17	otherwise required as provided in the Kansas offender registration act.
18	(b) "Sex offender" includes any person who:
19	(1) On or after April 14, 1994, is convicted of any sexually violent
20	crime;
21	(2) on or after July 1, 2002, is adjudicated as a juvenile offender for
22	an act which if committed by an adult would constitute the commission of
23	a sexually violent crime, unless the court, on the record, finds that the act
24	involved non-forcible sexual conduct, the victim was at least 14 years of
25	age and the offender was not more than four years older than the victim;
26	(3) has been determined to be a sexually violent predator;
27	(4) on or after July 1, 1997, is convicted of any of the following
28	crimes when one of the parties involved is less than 18 years of age:
29	(A) Adultery, as defined in K.S.A. 21-3507, prior to its repeal, or
30	K.S.A. 2021 Supp. 21-5511, and amendments thereto;
31	(B) criminal sodomy, as defined in K.S.A. $21-3505(a)(1)$ , prior to its
32	repeal, or K.S.A. 2021 Supp. 21-5504(a)(1) or (a)(2), and amendments
33	thereto;
34	(C) promoting prostitution, as defined in K.S.A. 21-3513, prior to its
35	repeal, or K.S.A. 2021 Supp. 21-6420, prior to its amendment by section
36	17 of chapter 120 of the 2013 Session Laws of Kansas on July 1, 2013;

1 (D) patronizing a prostitute, as defined in K.S.A. 21-3515, prior to its 2 repeal, or K.S.A. 2021 Supp. 21-6421, prior to its amendment by section 3 18 of chapter 120 of the 2013 Session Laws of Kansas on July 1, 2013; or 4 (E) lewd and lascivious behavior, as defined in K.S.A. 21-3508, prior 5 to its repeal, or K.S.A. 2021 Supp. 21-5513, and amendments thereto; 6 (5) is convicted of sexual battery, as defined in K.S.A. 21-3517, prior 7 to its repeal, or K.S.A. 2021 Supp. 21-5505(a), and amendments thereto; 8 (6) is convicted of sexual extortion, as defined in K.S.A. 2021 Supp. 9 21-5515, and amendments thereto; 10 (7) is convicted of an attempt, conspiracy or criminal solicitation, as defined in K.S.A. 21-3301, 21-3302 or 21-3303, prior to their repeal, or 11 K.S.A. 2021 Supp. 21-5301, 21-5302, 21-5303, and amendments thereto, 12 13 of an offense defined in this subsection; or 14 (8) has been convicted of an offense that is comparable to any crime defined in this subsection, or any out-of-state conviction for an offense that 15 under the laws of this state would be an offense defined in this subsection. 16 17 (c) "Sexually violent crime" means: 18 (1) Rape, as defined in K.S.A. 21-3502, prior to its repeal, or K.S.A. 19 2021 Supp. 21-5503, and amendments thereto; 20 (2) indecent liberties with a child, as defined in K.S.A. 21-3503, prior 21 to its repeal, or K.S.A. 2021 Supp. 21-5506(a), and amendments thereto; 22 (3) aggravated indecent liberties with a child, as defined in K.S.A. 23 21-3504, prior to its repeal, or K.S.A. 2021 Supp. 21-5506(b), and 24 amendments thereto: (4) criminal sodomy, as defined in K.S.A. 21-3505(a)(2) or (a)(3), 25 prior to its repeal, or K.S.A. 2021 Supp. 21-5504(a)(3) or (a)(4), and 26 27 amendments thereto; 28 (5) aggravated criminal sodomy, as defined in K.S.A. 21-3506, prior 29 to its repeal, or K.S.A. 2021 Supp. 21-5504(b), and amendments thereto; 30 (6) indecent solicitation of a child, as defined in K.S.A. 21-3510, 31 prior to its repeal, or K.S.A. 2021 Supp. 21-5508(a), and amendments 32 thereto; 33 (7) aggravated indecent solicitation of a child, as defined in K.S.A. 34 21-3511, prior to its repeal, or K.S.A. 2021 Supp. 21-5508(b), and 35 amendments thereto; 36 (8) sexual exploitation of a child, as defined in K.S.A. 21-3516, prior 37 to its repeal, or K.S.A. 2021 Supp. 21-5510, and amendments thereto; 38 (9) aggravated sexual battery, as defined in K.S.A. 21-3518, prior to 39 its repeal, or K.S.A. 2021 Supp. 21-5505(b), and amendments thereto; 40 (10) aggravated incest, as defined in K.S.A. 21-3603, prior to its 41 repeal, or K.S.A. 2021 Supp. 21-5604(b), and amendments thereto; 42 (11) electronic solicitation, as defined in K.S.A. 21-3523, prior to its 43 repeal, and K.S.A. 2021 Supp. 21-5509, and amendments thereto;

(13) aggravated human trafficking, as defined in K.S.A. 21-3447,
prior to its repeal, or K.S.A. 2021 Supp. 21-5426(b), and amendments
thereto, if committed in whole or in part for the purpose of the sexual
gratification of the defendant or another;

7 (14) commercial sexual exploitation of a child, as defined in K.S.A.

9 (15) promoting the sale of sexual relations, as defined in K.S.A. 2021
10 Supp. 21-6420, and amendments thereto;

(16) internet trading in child pornography or aggravated internet
trading in child pornography, as defined in K.S.A. 2021 Supp. 21-5514,
and amendments thereto;

(17) any conviction or adjudication for an offense that is comparable
 to a sexually violent crime as defined in this subsection, or any out-of-state
 conviction or adjudication for an offense that under the laws of this state
 would be a sexually violent crime as defined in this subsection;

(17)(18) an attempt, conspiracy or criminal solicitation, as defined in
 K.S.A. 21-3301, 21-3302 or 21-3303, prior to their repeal, or K.S.A. 2021
 Supp. 21-5301, 21-5302, 21-5303, and amendments thereto, of a sexually
 violent crime, as defined in this subsection; or

(18)(19) any act-which *that* has been determined beyond a reasonable doubt to have been sexually motivated, unless the court, on the record, finds that the act involved non-forcible sexual conduct, the victim was at least 14 years of age and the offender was not more than four years older than the victim. As used in this paragraph, "sexually motivated" means that one of the purposes for which the defendant committed the crime was for the purpose of the defendant's sexual gratification.

(d) "Sexually violent predator" means any person who, on or after
July 1, 2001, is found to be a sexually violent predator pursuant to K.S.A.
59-29a01 et seq., and amendments thereto.

(e) "Violent offender" includes any person who:

33 (1) On or after July 1, 1997, is convicted of any of the following 34 crimes:

(A) Capital murder, as defined in K.S.A. 21-3439, prior to its repeal,
or K.S.A. 2021 Supp. 21-5401, and amendments thereto;

(B) murder in the first degree, as defined in K.S.A. 21-3401, prior to
its repeal, or K.S.A. 2021 Supp. 21-5402, and amendments thereto;

(C) murder in the second degree, as defined in K.S.A. 21-3402, prior
to its repeal, or K.S.A. 2021 Supp. 21-5403, and amendments thereto;

41 (D) voluntary manslaughter, as defined in K.S.A. 21-3403, prior to its 42 repeal, or K.S.A. 2021 Supp. 21-5404, and amendments thereto;

(F) kidnapping, as defined in K.S.A. 21-3420, prior to its repeal, or
K.S.A. 2021 Supp. 21-5408(a), and amendments thereto;

7 (G) aggravated kidnapping, as defined in K.S.A. 21-3421, prior to its 8 repeal, or K.S.A. 2021 Supp. 21-5408(b), and amendments thereto;

9 (H) criminal restraint, as defined in K.S.A. 21-3424, prior to its 10 repeal, or K.S.A. 2021 Supp. 21-5411, and amendments thereto, except by 11 a parent, and only when the victim is less than 18 years of age; or

(I) aggravated human trafficking, as defined in K.S.A. 21-3447, prior
to its repeal, or K.S.A. 2021 Supp. 21-5426(b), and amendments thereto, if
not committed in whole or in part for the purpose of the sexual
gratification of the defendant or another;

16 (2) on or after July 1, 2006, is convicted of any person felony and the 17 court makes a finding on the record that a deadly weapon was used in the 18 commission of such person felony;

(3) has been convicted of an offense that is comparable to any crime
defined in this subsection, any out-of-state conviction for an offense that
under the laws of this state would be an offense defined in this subsection;
or

(4) is convicted of an attempt, conspiracy or criminal solicitation, as
defined in K.S.A. 21-3301, 21-3302 or 21-3303, prior to their repeal, or
K.S.A. 2021 Supp. 21-5301, 21-5302 and 21-5303, and amendments
thereto, of an offense defined in this subsection.

(f) "Drug offender" includes any person who, on or after July 1, 2007:

(1) Is convicted of any of the following crimes:

(A) Unlawful manufacture or attempting such of any controlled
substance or controlled substance analog, as defined in K.S.A. 65-4159,
prior to its repeal, K.S.A. 2010 Supp. 21-36a03, prior to its transfer, or
K.S.A. 2021 Supp. 21-5703, and amendments thereto;

(B) possession of ephedrine, pseudoephedrine, red phosphorus,
lithium metal, sodium metal, iodine, anhydrous ammonia, pressurized
ammonia or phenylpropanolamine, or their salts, isomers or salts of
isomers with intent to use the product to manufacture a controlled
substance, as defined in K.S.A. 65-7006(a), prior to its repeal, K.S.A. 2010
Supp. 21-36a09(a), prior to its transfer, or K.S.A. 2021 Supp. 21-5709(a),
and amendments thereto;

2 (2) has been convicted of an offense that is comparable to any crime defined in this subsection, any out-of-state conviction for an offense that 3 4 under the laws of this state would be an offense defined in this subsection; 5 or

6 (3) is or has been convicted of an attempt, conspiracy or criminal 7 solicitation, as defined in K.S.A. 21-3301, 21-3302 or 21-3303, prior to 8 their repeal, or K.S.A. 2021 Supp. 21-5301, 21-5302 and 21-5303, and 9 amendments thereto, of an offense defined in this subsection.

(g) Convictions or adjudications-which that result from or are 10 connected with the same act, or result from crimes committed at the same 11 time, shall be counted for the purpose of this section as one conviction or 12 adjudication. Any conviction or adjudication set aside pursuant to law is 13 14 not a conviction or adjudication for purposes of this section. A conviction 15 or adjudication from any out-of-state court shall constitute a conviction or 16 adjudication for purposes of this section.

(h) "School" means any public or private educational institution, 17 including, but not limited to, postsecondary school, college, university, 18 19 community college, secondary school, high school, junior high school, middle school, elementary school, trade school, vocational school or 20 21 professional school providing training or education to an offender for three 22 or more consecutive days or parts of days, or for 10 or more 23 nonconsecutive days in a period of 30 consecutive days.

(i) "Employment" means any full-time, part-time, transient, day-labor 24 25 employment or volunteer work, with or without compensation, for three or more consecutive days or parts of days, or for 10 or more nonconsecutive 26 27 days in a period of 30 consecutive days.

28 "Reside" means to stay, sleep or maintain with regularity or (i) 29 temporarily one's person and property in a particular place other than a location where the offender is incarcerated. It shall be presumed that an 30 31 offender resides at any and all locations where the offender stays, sleeps or 32 maintains the offender's person for three or more consecutive days or parts 33 of days, or for ten or more nonconsecutive days in a period of 30 34 consecutive days.

35 (k) "Residence" means a particular and definable place where an 36 individual resides. Nothing in the Kansas offender registration act shall be 37 construed to state that an offender may only have one residence for the 38 purpose of such act. 39

(1) "Transient" means having no fixed or identifiable residence.

(m) "Law enforcement agency having initial jurisdiction" means the 40 registering law enforcement agency of the county or location of 41 jurisdiction where the offender expects to most often reside upon the 42 43 offender's discharge, parole or release.

"Registering law enforcement agency" means the sheriff's office 1 (n) 2 or tribal police department responsible for registering an offender.

(o) "Registering entity" means any person, agency or other 4 governmental unit, correctional facility or registering law enforcement 5 agency responsible for obtaining the required information from, and 6 explaining the required registration procedures to, any person required to 7 register pursuant to the Kansas offender registration act. "Registering 8 entity"-shall include includes, but is not-be limited to, sheriff's offices, tribal police departments and correctional facilities. 9

(p) "Treatment facility" means any public or private facility or 10 institution providing inpatient mental health, drug or alcohol treatment or 11 counseling, but does not include a hospital, as defined in K.S.A. 65-425, 12 13 and amendments thereto.

14 (q) "Correctional facility" means any public or private correctional facility, juvenile detention facility, prison or jail. 15

16 (r) "Out-of-state" means: the District of Columbia; any federal, 17 military or tribal jurisdiction, including those within this state; any foreign 18 jurisdiction; or any state or territory within the United States, other than 19 this state.

"Duration of registration" means the length of time during which 20 (s) 21 an offender is required to register for a specified offense or violation.

22 (t) (1) Notwithstanding any other provision of this section, "offender" 23 shall not include any person who is:

24 (A) Convicted of unlawful transmission of a visual depiction of a 25 child, as defined in K.S.A. 2021 Supp. 21-5611(a), and amendments thereto, aggravated unlawful transmission of a visual depiction of a child, 26 27 as defined in K.S.A. 2021 Supp. 21-5611(b), and amendments thereto, or 28 unlawful possession of a visual depiction of a child, as defined in K.S.A. 29 2021 Supp. 21-5610, and amendments thereto;

30 (B) adjudicated as a juvenile offender for an act which if committed 31 by an adult would constitute the commission of a crime defined in 32 subsection (t)(1)(A); or

33 (C) adjudicated as a juvenile offender for an act which if committed 34 by an adult would constitute the commission of sexual extortion as defined 35 in K.S.A. 2021 Supp. 21-5515, and amendments thereto.

36 (2) Notwithstanding any other provision of law, a court shall not 37 order any person to register under the Kansas offender registration act for 38 the offenses described in subsection (t)(1).

- 6 (7) sexual exploitation of a child, as defined in K.S.A. 21-3516, prior 7 to its repeal, or K.S.A. 2021 Supp. 21-5510, and amendments thereto, if 8 the victim is less than 14 years of age;
- 9 (8) promoting prostitution, as defined in K.S.A. 21-3513, prior to its 10 repeal, or K.S.A. 2021 Supp. 21-6420, prior to its amendment by section 11 17 of chapter 120 of the 2013 Session Laws of Kansas on July 1, 2013, if 12 the person selling sexual relations is less than 14 years of age;
- (9) kidnapping, as defined in K.S.A. 21-3420, prior to its repeal, or
  K.S.A. 2021 Supp. 21-5408(a), and amendments thereto;
- (10) aggravated kidnapping, as defined in K.S.A. 21-3421, prior to its
  repeal, or K.S.A. 2021 Supp. 21-5408(b), and amendments thereto;
- (11) aggravated internet trading in child pornography, as defined in *K.S.A.* 2021 Supp. 21-5514, and amendments thereto, if the victim is less
  than 14 years of age;

(12) commercial sexual exploitation of a child, as defined in K.S.A.
2021 Supp. 21-6422, and amendments thereto; or

(12)(13) any attempt, conspiracy or criminal solicitation, as defined
in K.S.A. 21-3301, 21-3302 or 21-3303, prior to their repeal, or K.S.A.
2021 Supp. 21-5301, 21-5302 and 21-5303, and amendments thereto, of an
offense defined in this subsection.

(e) Any person who has been declared a sexually violent predator
pursuant to K.S.A. 59-29a01 et seq., and amendments thereto, shall
register for such person's lifetime.

(f) Notwithstanding any other provisions of this section, for an
offender less than 14 years of age who is adjudicated as a juvenile offender
for an act which if committed by an adult would constitute a sexually
violent crime set forth in K.S.A. 22-4902(c), and amendments thereto, the
court shall:

(1) Require registration until such offender reaches 18 years of age, at the expiration of five years from the date of adjudication or, if confined, from release from confinement, whichever date occurs later. Any period of time during which the offender is incarcerated in any jail, juvenile facility or correctional facility or during which the offender does not comply with any and all requirements of the Kansas offender registration act shall not count toward the duration of registration;

41 (2) not require registration if the court, on the record, finds substantial42 and compelling reasons therefor; or

43 (3) require registration, but such registration information shall not be

open to inspection by the public or posted on any internet website, as provided in K.S.A. 22-4909, and amendments thereto. If the court requires registration but such registration is not open to the public, such offender shall provide a copy of such court order to the registering law enforcement agency at the time of registration. (1) Require registration until such offender reaches 18 years of age, at
the expiration of five years from the date of adjudication or, if confined,
from release from confinement, whichever date occurs later. Any period of
time during which the offender is incarcerated in any jail, juvenile facility
or correctional facility or during which the offender does not comply with
any and all requirements of the Kansas offender registration act shall not
count toward the duration of registration;

(2) not require registration if the court, on the record, finds substantialand compelling reasons therefor; or

27 (3) require registration, but such registration information shall not be 28 open to inspection by the public or posted on any internet website, as 29 provided in K.S.A. 22-4909, and amendments thereto. If the court requires 30 registration but such registration is not open to the public, such offender 31 shall provide a copy of such court order to the registering law enforcement 32 agency at the time of registration. The registering law enforcement agency 33 shall forward a copy of such court order to the Kansas bureau of 34 investigation.

If such offender violates a condition of release during the term of the conditional release, the court may require such offender to register pursuant to paragraph (1).

(h) Notwithstanding any other provisions of this section, an offender 14 years of age or more who is adjudicated as a juvenile offender for an act which if committed by an adult would constitute a sexually violent crime set forth in K.S.A. 22-4902(c), and amendments thereto, and such crime is an off-grid felony or a felony ranked in severity level 1 of the nondrug grid as provided in K.S.A. 21-4704, prior to its repeal, or K.S.A. 2021 Supp. 21-6804, and amendments thereto, shall be required to register
 for such offender's lifetime.

3 (i) Notwithstanding any other provision of law, if a diversionary 4 agreement or probation order, either adult or juvenile, or a juvenile 5 offender sentencing order, requires registration under the Kansas offender 6 registration act for an offense that would not otherwise require registration 7 as provided in K.S.A. 22-4902(a)(5), and amendments thereto, then all 8 provisions of the Kansas offender registration act shall apply, except that 9 the duration of registration shall be controlled by such diversionary 10 agreement, probation order or juvenile offender sentencing order.

(j) The duration of registration does not terminate if the convicted or
 adjudicated offender again becomes liable to register as provided by the
 Kansas offender registration act during the required period of registration.

14 (k) For any person moving to Kansas who has been convicted or adjudicated in an out-of-state court, or who was required to register under 15 16 an out-of-state law, the duration of registration shall be the length of time required by the out-of-state jurisdiction or by the Kansas offender 17 18 registration act, whichever length of time is longer. The provisions of this 19 subsection shall apply to convictions or adjudications prior to June 1, 20 2006, and to persons who moved to Kansas prior to June 1, 2006, and to 21 convictions or adjudications on or after June 1, 2006, and to persons who 22 moved to Kansas on or after June 1, 2006.

(1) For any person residing, maintaining employment or attending school in this state who has been convicted or adjudicated by an out-ofstate court of an offense that is comparable to any crime requiring registration pursuant to the Kansas offender registration act, but who was not required to register in the jurisdiction of conviction or adjudication, the duration of registration shall be the duration required for the comparable offense pursuant to the Kansas offender registration act.
