(16) one individual selected to represent the seven regional homeland security councils.

(d) A designee of the adjutant general shall serve as the secretary of the commission on emergency planning and response. The adjutant general shall provide staff support for the commission on emergency planning and response.
(e) Of the members first appointed to the commission on emergency planning and response by the governor, one representative of cities, one

planning and response by the governor, one representative of cities, one representative of counties and one representative of business and industry shall serve a term of two years, and the remainder of the members appointed by the governor shall serve terms of three years. Thereafter, members appointed pursuant to subsection (c) shall serve terms of four years and until the successor has been appointed. Any vacancy in the office of an appointed member shall be filled for the unexpired term by appointment by the governor.

(f) A chairperson shall be elected annually by the members of the commission. A vice-chairperson shall be designated by the chairperson to serve in the absence of the chairperson. The members serving as chairperson and vice-chairperson on July 1, 2013, shall serve in such positions until a date which is two years after the date the chairperson was elected. At such time, the vice-chairperson shall become chairperson and a new vice-chairperson, having been elected by the members of the commission, shall be seated. The chairperson and the vice-chairperson shall serve in such capacity for a period of two years, and at the conclusion of each two year period thereafter, the vice-chairperson shall become chairperson and a new vice-chairperson, having been elected by the members of the commission, shall be seated. The vice-chairperson shall serve in the absence of the chairperson.

(g) For attending meetings of such commission, or attending a subcommittee meeting thereof authorized by such commission, those members of the commission appointed by the governor shall be paid compensation, subsistence allowances, mileage and other expenses as provided in K.S.A. 75-3223, and amendments thereto.

Sec. 2. K.S.A. 2012 Supp. 65-5721 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the statute book.
