Neutral testimony – creating government subsidy

The Kansas Board of Healing Arts (KSBHA) appreciates the opportunity to provide neutral testimony on SB 10. The KSBHA presently licenses and regulates 14 health care professions. The mission of the KSBHA is to safeguard the public and strengthen the healing arts – public protection. Public protection encompasses several critical components, including ensuring the character and competence of an applicant before granting licensure and remediating or disciplining licensees who violate their practice act.

SB 10 eliminates the ability for state agencies to charge staff time required to respond to open record requests.

As a public agency we strive to be responsive to open record requests, fulfill our mission of public protection and transparency. KSBHA is a fee funded agency which means that all operational expenses are paid for by the licensing fees paid by licensees. The legislature has consistently encouraged state agencies to operate like private sector business – efficient and effective. Generally speaking, private sector businesses charge for time and materials. SB 10 would prohibit KSBHA from charging for costs associated with open record requests. Thus, open record requests from the media, plaintiff attorneys, or others would be subsidized by licensee fees – creating a government subsidy.

KSBHA is required by many state and federal laws to hold the medical records and other documents held by this agency confidential. The costs of an open records request is NOT just locating and copying requested records. A substantial amount of staff time is dedicated to reviewing all records and redacting information that is confidential pursuant to statute. Attached is a copy of some of the state and federal statutes that prohibit release of confidential information.
