Madame President, SB 516 would disallow those businesses having governmental contracts valued at greater than \$10,000 from making campaign contributions to officials of that particular governmental body, either at the state or local level. Our constituents continue to lose faith in our institutions of government, Madame President, as they repeatedly hear news stories about the special interests and the lack of scrutiny regarding their business relationships with governing bodies. This bill attempts to begin restoration of that confidence by reducing the special interests' undue influence over elected officials.
